5. What attracted attention to object: A flashing object
in the sky.
6. Number of objects: One object.
7. Apparent size: About the size of my thumb nail at
arm length.
8. Color of object: Silver.
9. Shape: Round and thin like a quarter dollar. Apparently
rocked giving an edgewise and sidewise view. Rocking at irregular
intervals.
10. Altitude: About a 30° angle.
11. Direction from observer: Approximately 2/3 distance to
Hueco Mountains.

Comments of interrogator relative to intelligence and character
of observer:

An interview with enlisted men of the 39th AAA Battalion revealed
that the observers are reliable in character and intelligence.

Did observer wear glasses, especially polaroid glasses at time of
sighting or was object viewed through canopy, window, or other transparent
material: Binoculars were used by Cpl [REDACTED] and Pvt [REDACTED] after
initial observation.

5. Did object contact the earth: Object did not contact the earth.



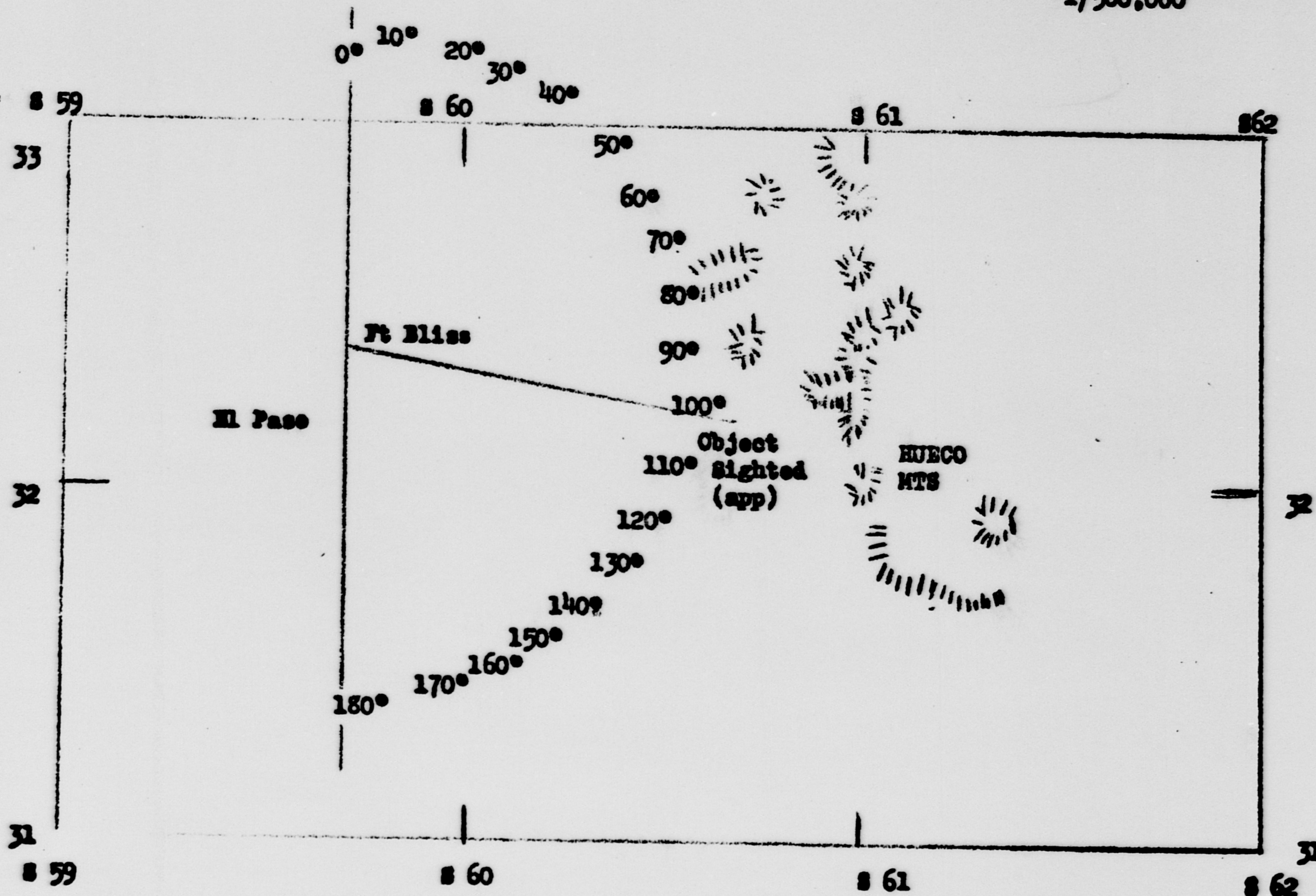

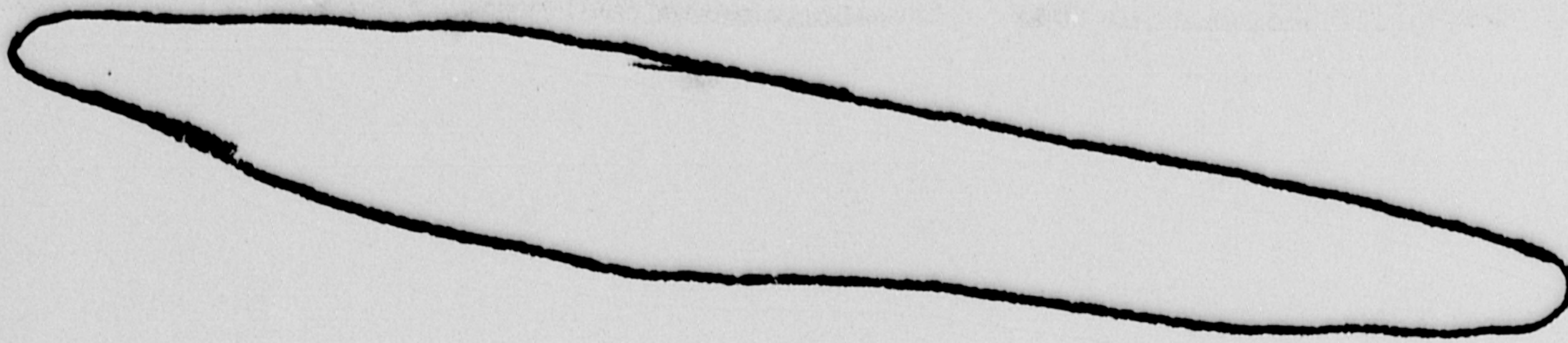

13. Direction of flight of object: Moved away at about 100° and slowly ascending.

14. Time in sight: Approximately 5 minutes.

15. Speed: In 5 minutes it apparently moved about 15 to 20 miles judging from its position at time of first sight to a position apparently over the mountain range.

16. Sound or odor: None

17. Trail: None

18. Luminosity: Reflection

19. Projections: None

20. Maneuvers: Irregular rolling and tilting motion slowly rising as it travelled away.

21. Manner of disappearance: See #9.

22. Effect of clouds: Saw it first without glasses and still saw it through tinted binoculars.
