████████ stated, that at approximately 1700 hours on the 22 May 1949, that he, his wife, his son and ██████████ ██████████, Shreveport, La., his son's guest were on a fishing party at Caddo Lake when their attention was attracted to an F-82 flying across the lake. While they were watching the F-82, Miss ██████████ noticed the unknown object and directed their attention to it. ██████████ further stated that when he first sighted this object, it was approximately Two (2) miles away at an angle of Sixty (60) Degrees and at an extremely high altitude which he estimated to be Eight (8) to Ten (10) thousand feet. He estimated the object to have remained in sight approximately Four (4) minutes and that it was silver in color, oblong shaped, metal construction and approximately the size of baseball. ██████████ estimated the direction of flight as being southeast. The flight path was a continued straight line and there was no sound connected with the object. ██████████ stated that due to the height of the object he was unable to see any details. He estimated the speed of the object at Five hundred (500) miles per hour and stated it continued in straight flight until it faded from view.

The son, ██████████ ██████████, Shreveport, Louisiana, in an interview 24 May 1949, stated in effect the same details as given by his father with the exception that his estimate of the time the object was in sight was Three (3) minutes and angle of sight Thirty five (35) Degrees. He further stated that he felt the incident should be reported because of an article he had seen concerning the sighting of a "Flying Saucer" in New Orleans carried in the Shreveport Times, 24 May 1949. The article stated that ██████████ ██████████, New Orleans, Louisiana saw an object that resembled a huge baseball at very high altitude at 18:50 hours. The dateline on the article was AP, May 23, 1949.

A routine check conducted on the reliability of the observers was favorable.

████████ is a civil service employee employed at Barksdale Air Force Base, Shreveport, Louisiana as the paint shop foreman in the Base engineering shops.

████████ is employed by the Fulton Loan Company, Slattery Building, Shreveport, Louisiana.

At the time of the sighting of this object the ceiling and visibility was unlimited and there was a bright sun.

Agent, ██████████

At 1700, 22 May 1949 the reporting Officer was in Bossier City, La which is approx 15 miles from Caddo Lake when he sighted an aircraft positively identified as a B-36 at an estimated altitude of 30,000 ft. It was very difficult to identify as an aircraft due to the bright sun, but the distinctive sound of the B-36 was easily discernible.

In the opinion of the reporting officer it is possible that the reported object was the same or a similar aircraft as the ability of the observers to accurately estimate altitude is doubtful.
