

SYNOPSIS <p>On 8 August 1949, at 2030 hours, Mr. [REDACTED], Forrest County, Mississippi, observed from the front porch of his home at [REDACTED] Street, Hattiesburg, Mississippi, an unidentified object traveling through the sky at a great rate of speed. Mr. [REDACTED] described the object as sphere shaped with a very soft yellowish glowing light approximately the size of a common soft ball. This object remained in sight for approximately one second and moved from sight by passing behind trees.</p> <p>On 8 August 1949, 2030 hours, Mr. [REDACTED] Hattiesburg, Mississippi, observed an object traveling across the sky at a speed which Mr. [REDACTED] described as being "faster than any jet plane I have ever seen". This object was circular in shape and tapered to an almost fine point. The entire object was luminous. The foremost portion gave off an extremely yellowish glow and the tapering end faded into a bluish color. This object remained in sight for approximately one second.</p>

<p>At 2000 hours on 8 Aug 49, at Biloxi, Mississippi, an unidentified object was sighted in the sky by 1st Lt W. T. Prebis of Keesler AFB, Miss. The object sighted appeared to be in the shape of a large beach ball about two (2) feet in diameter. The object was a bright yellow in color with a faint glow around it as though seen through a mist, as the moon appears when seen through a thin fog. It was traveling at a speed estimated at from 600 to 800 mph. The object was at an altitude of approximately 1,000 feet and was below the clouds and in the clear (VFR). The observer could distinguish no definite sounds coming from the object because of the sounds of local traffic and aircraft flying local from Keesler AFB (Four B-25s and one T-6). When the object disappeared after being in sight for only about twenty (20) seconds, it just seemed to blink out and was gone. There was no exhaust visible. No distinguishing features were noted.</p> <p>The sighting of this object took place only seventeen (17) hours after a similar object was reported being seen hurtling across New Orleans, Louisiana.</p> <p><i>D-20</i></p>
