



STATEMENT BY OBSERVER: At 0228, as I was rounding corner (SW) of the foundry, the light was observed to be just above the horizon. As the light was under observation for only 2 seconds the direction, speed, etc, are approximated. However, just as the light seemed to be at its lowest point in flight, it wavered as though it had either been affected by a reduction in speed or had hit something on the ground. To all appearances, this object did NOT disappear behind the horizon but behind a hill.

Dear Sir:

This office has been informed by [REDACTED] scientist with Group P-9 of the Los Alamos Scientific Laboratory, of the following celestial phenomena observed at approximately 1950 hours, November 16, 1949, at Los Alamos:

Two bluish-green lights (similar to that given off by burning zinc) in tandem were seen overhead, slightly south of the zenith. They appeared to be stationary, but suddenly curved around and disappeared to the north with the speed of a meteor. No sound was heard in conjunction with this observation.

Mr. [REDACTED] said that his attention had been called to the sky by some children who reported having seen erratically moving green lights, and it was while he was looking, in response to their questions, that he observed the phenomena described above.

On November 25, 1949, at approximately 2000 hours, a light yellowish-green object was observed for about two seconds, from a point on the northern part of the project, by the following staff members of the Los Alamos Scientific Laboratory: ~~_____~~

~~_____~~s. The object appeared as a point of light, much brighter than any star, at about 350 degrees and 15 degrees elevation, moving from east to west, for approximately 50 degrees, and downward at about 10 degrees from the horizontal. It was first seen by ~~_____~~, who yelled "There it is, there it is." The other observers turned around in time to see the latter part of the trajectory as it disappeared behind the Jemez Range. Distance from the point of observation, altitude, and speed could not be estimated, and there was no sound heard in connection with this phenomenon.

These observations are being reported for your information in coordinating such reports in this area.

Gentlemen;

My wife and I have a first class case of the JITTERS not because of what we have witnessed but for fear we too would be the source of laughter should we make it public.

When stories relating to Flying Saucers and Disks made their appearance I was inclined to believe they were based on illusions or imaginary objects and like the majority of people did not attach particular significance to them.

When Mr. Sidney Shalett published his articles relating to them in the Saturday Evening Post I accepted his doubts and explanations as they referred to specific cases. Especially in view of the fact our Government denied all responsibility for possible experimental missiles.

But now, in the light of our own experience, I am not too sure. Possibly there are strange, man made objects traveling through the atmosphere. Being reasonably intelligent we have decided to submit the following report for what it might be worth.

We live on a high hill overlooking our community. We became sky conscious during the war due to many planes flying over our home in a north-south direction. Since the war, Capital, Eastern and Piedmont planes continue to fly this course. Hence we are accustomed to looking sky-ward both day and night.

Saturday afternoon, October the first, at five P.M., my wife and I were standing on the hill near our home, and by chance, I was looking direct at the Southern Sky. Then suddenly, there entered the field of vision a strange object. Sensing something unusual I grabbed my wife by the arm and pointing skyward, shouted, do you see what I see. "Yes I do she replied" and after its disappearance we stood silent, in astonishment, for a moment before either could speak.

This object came into the field of vision on about a 45 degree angle, traveling at a terrific speed, due north, and vanished from sight at about the same position it had become visible. During the few seconds it was visible I tried to make a careful observation as to its general contour and etc.

Generally speaking, the best way I can describe this device is to state, that from the ground, it looked like a sheet of metal from four to five feet in length and thirty inches wide with rounded corners.

It had no wings nor other protrusions, neither was there any sound, smoke, nor vapor to be seen nor heard. Only the bottom could be seen from the ground, height and speed made it impossible to ascertain ~~its~~ heights or depth. The bottom was smooth, remained parallel with the earth, (no waivering) had a metallic appearance but did not glisten in sun light. The color was that of lead or tarnished tin.


In flight it followed a straight course, maintained a fixed equilibrium, traveled longwise as illustrated, appeared and disappeared with marked suddenness.

In my mind I am unable to correlate this object with any of the various manifestations produced by government balloons as listed by Mr. Shalett. The nearest coincident he listed was the case of the two aviators who saw an object alongside their plane and later checked with their passengers for confirmation. However in their case it was night time and they were also in the air affording more complete observation.

What we saw was no illusion nor hallucination. I studied medicine and have some knowledge of them. It was no heavenly body. I have read three books on astronomy including a college text and many articles. It was no airplane of common knowledge. To us, until disproved, it was a man made, mechanical gadget, origin unknown.

Henceforth I will no doubt, doubt, the conclusions of Mr. Shalett and those who supported him in his articles. Possibly some of the reports are not illusions nor fragments of the imagination. Maybe strange objects are sailing above our heads from here or abroad.

(7) General remarks: [REDACTED] stated that while traveling along, approximately three (3) miles northeast on highway #31 going north out of Holland, Michigan on the 2 October 1949, he sighted a very bright and shiny object shaped like a dinner plate. Going east the object approached beneath a transparent cloud, the object did a flip, and went up into the cloud. [REDACTED] expected the object to come out of the other side of the cloud, but instead it came out at the point of entry, and traveled back along its original route and then disappeared into the east. [REDACTED] claims that the object was in his sight for approximately 30 to 60 seconds. It is to be noted that at the time of sighting [REDACTED] was traveling along a heavily traveled highway, and approaching a turn. [REDACTED] states that while approaching the turn in the highway he noticed a barn just right of the turn. The object sighted was just about the height of a yard stick above the barn in his line of sight. [REDACTED] stated that he judged the cloud formations on the 2 of October 1949 to be from 5 to 10 thousand feet.

It is the belief of the undersigned that there is considerable margin for error in this report, in view of the fact that the individual making the report was traveling down a well traversed highway, and also approaching a turn. The time element involved in viewing this object was probably not as great as is indicated due to circumstances at the time of sighting. Also the official CAA weather report indicates that the cloud formations on this day in question in this locality were supposed to be at an altitude of 25,000 feet.

Background of the individual is as follows: Spent 52 months in the USAAF from early 1941 to late 1945. He spent 31 months in England, France and Germany, with a B-26 Unit, the 896th Air Engineer Squadron of the 344th Bomb Group.
