1. On 23 May 1951 source received a telephone call from a person identifying herself as Mrs. [REDACTED] of [REDACTED], Great Falls, Montana, who reported that she sighted an unidentified aerial object over the city of Great Falls between 1430 and 1500 hours (MDT) on 22 May 1951. The woman stated that the object, which was silver or a bluish white shade, appeared to be shaped like a ball or a three-pointed star and gave off a glow similar to that of an electric light bulb. During the visual observation, the object disappeared from sight occasionally against the blue background but consistently reappeared against the same blue background. The object appeared to the observer to be at very high altitude and was moving slowly in a general west-to-east direction.
2. Source contacted the Great Falls AFB weather detachment and the Core Field weather station. The former had no weather balloons in the air at that time, but the latter reported that they had released a balloon at 1400 hours on 22 May 1951. This balloon was white and moved in a west-to-east direction in its ascent.
3. A Great Falls radio station reported that a Northwest Airlines pilot reported seeing the same unidentified aerial object.
4. Another newscast on 23 May 1951 reported that an unidentified object of similar description was sighted over Kansas City [sic].
