Capt [REDACTED] at time of observation called it in as a bogey to his flight but his transmission was weak and was not heard by the others in the flight. It wasn't until after they had landed and were discussing the object that either observer knew that the other one had seen it. The two observations were made separately without being called to their attention at the time seen.

15 May 1952

Returning from target area May 15, 1952 I was flying number four position. At approximately 1835 hour I first sighted this object. Our altitude was 9000 feet. First sighted object at about one o'clock position from our flight. By the time I called the object in as a bogie, it had moved to the three o'clock position and started a steep climb, which I assumed was the beginning of a loop, but at the vertical position in the loop, the object moved forward in its original course of travel (360°) and wavered momentarily and then descended and disappeared into the haze which reached an altitude of approximately 7000-8000 feet.





12. Extracted from FEAf "Intsum" #717, dtd 0320/Z, 13 June 1952:

Enemy balloons: Recently several reports have been received concerning the sighting of an unidentified object in the air having a primary color of white changing to red, then to green, and located in the area of DT 201398. These observations were made on 10 May and on 4, 6, and 7 June between the hours of 2102/I and 2400/I. In the majority of cases the object was described as being egg shaped or round, at an altitude estimated between 1000 ft and 10,000 feet, and in one case it was reported to have moved very rapidly horizontally for a distance. This movement was observed through a battery commander's scope and measured for 10 miles of travel, but the operator reported that he could not traverse fast enough to keep on target. This object was observed on 7 June for 1 hour and 5 minutes by a trained Air Technical Intelligence specialist and an ordnance Technical Intelligence specialist. As a result of these observations, a forward observer investigated the area at 091145/I June and saw a balloon being raised and lowered on a cable. D/I FEAf Comment: Most of the previous sightings of unidentified objects have occurred in the CT and DT grid areas. The high horizontal speed of the one sighting could be accounted for by a free balloon caught in a horizontal draft in the mountainous areas of that sector. The purpose of raising and lowering a balloon so near the front lines is not apparent, but could possibly be a method of communication.

<p>6. Extracted from Fifth Air Force "Perintrep", 19 May 1952:</p> <p>Balloon sightings: At 160210-I, vicinity of CT 4035, an F-94 crew observed a balloon approximately 3 feet in diameter. Observation was made by means of a small light suspended from the balloon. The balloon was first observed at 13000 feet and the F-94 followed to 24000 feet. Estimated rate of climb of balloon was 2000 ft/min, as the F-94 had to use afterburner in the chase. The balloon was shot down over CT 4016. At 160353-I, vicinity CT 2828, an F-94 crew again observed a balloon, this time at 12000 feet. Again by means of a steady burning light suspended from the 3 to 6 feet diameter balloon. Friendly pursued the balloon using afterburner, shooting it down at CT 4010. The white light, described as "Very powerful," was still burning as the balloon fell. D/I Comment (5th AF) - Further investigation is being made by the 6004th AISS.</p> <p>a.
