<p>S/Sgt Samuel R. Locke, AF37606090, Asst Tech Inspector, Wing Inspectors Office, Hq Sq See, Wing, stated that he observed the object at approximately 2240 hours CST, 21 July 1952. He and his wife were returning from Lockhart to San Marcos, at Maxwell, Texas, he and his wife noticed an object. It looked like something had exploded and it gave off a red flame and started to descend with a following blue flame which was very bright and appeared like a flare. It descended to about a estimated 5000 feet. It stopped and appeared white in color and he could identify the object as being round. The color seemed to change to a very light yellow and the object moved off to the south. It was traveling quite fast.</p>				
<p>S/Sgt Thedford R. Townsend, AF35604157, Air Policeman, Air Police Squadron, stated that at approximately 2240 hours CST, 21 July 1952, he was leaving the gunroom in his squadron area when he looked up into the sky and saw a bluish-green object make an arc in the sky. The light from the trail was a bluish-green for a second or two and then the light disappeared.</p>				
<p>A/1C David McKenzie, AF19306627, Air Policeman, Air Police Squadron, stated that at approximately 2240 hours CST, 21 July 1952, he was going to Air Police Headquarters and observed a bluish-green light in the sky. It ascended and descended very rapidly and then disappeared. There was no noise whatsoever.</p>				
<p>A/2C Frank R. Norred, AF14394366, Air Policeman, Air Police Squadron, stated that at approximately 2240 hours CST, 21 July 1952, he noticed a blue-green light falling at a great speed. It looked somewhat like a falling star. It was moving too fast to tell the size. It was in the air only 7 to 10 seconds.</p>				
<p>A/3C Paul M. Nelson Jr, AF13432318, Air Policeman, Air Police Squadron, stated that at approximately 2245 hours CST, 21 July 1952, he was making his rounds as the fence guard and noticed a reddish-yellow object in the sky. It seemed to be traveling very slow. Far away you could hear a low roaring noise but as this object passed overhead he could hear nothing. The object at first did not bother him too much because he just thought it was an airplane. When it kept coming over the base (approximately four times) it gained his attention. Off hand he would say that this object was traveling at the rate of 75 miles per hour. In other words it was going slow enough so that if it were used for some sort of operation, it could reveal some strategic points on the base. Afterwards it just simply disappeared in the sky. A couple fellows and he talked about what they had seen and a couple other guys that were standing around laughed as if it were a joke. Things of that type are no joke.</p>

1. Major Bremmer, OSI, Langley AF Base, called this office to inform the DCS/I of a report of an unidentified flying object which had been telephoned to him from the 5th Naval District, Norfolk, Virginia.

2. Lt Commander P. H. Bucklew, stationed at the Amphibious Base, Little Creek, Virginia, was contacted by Mr. [REDACTED], Vice President of a Pulp and Paper Mill in North Carolina, who observed the object.

3. Mr. [REDACTED] reported that he and two friends were on the beach at Nagshead, North Carolina at 2335 hours, 21 July 1952, when they observed three objects flying in a southwest direction. They were very high and flying in echelon formation. The lead object would draw away and the other two objects would close in. They observed the objects for approximately three minutes before they disappeared.

4. Mr. [REDACTED] stated that one of his friends was a man who had a considerable amount of experience in aviation, having been a pilot for thirty years. This man stated that he had "never seen anything like that".

5. Mr. [REDACTED] is presently staying at the Carolean Hotel at Nagshead Beach, and will be there for two weeks.
