5. Reference CIRVIS report 280036P submitted by March Flight Service Center. At 1215P 28 July 1952 an object was sighted in the vicinity of Los Angeles International Airport. Object was described as very high and resembled a star when first sighted. Observer lined it up with telephone wires and a revolving motion accompanied by vertical oscillation was noted. Green and red; intensely bright flashes, accompanied at times by a smaller light above the object, were also noted. The object then appeared to recede, grow dimmer, and finally disappeared. Length of observation: 2 minutes. 24

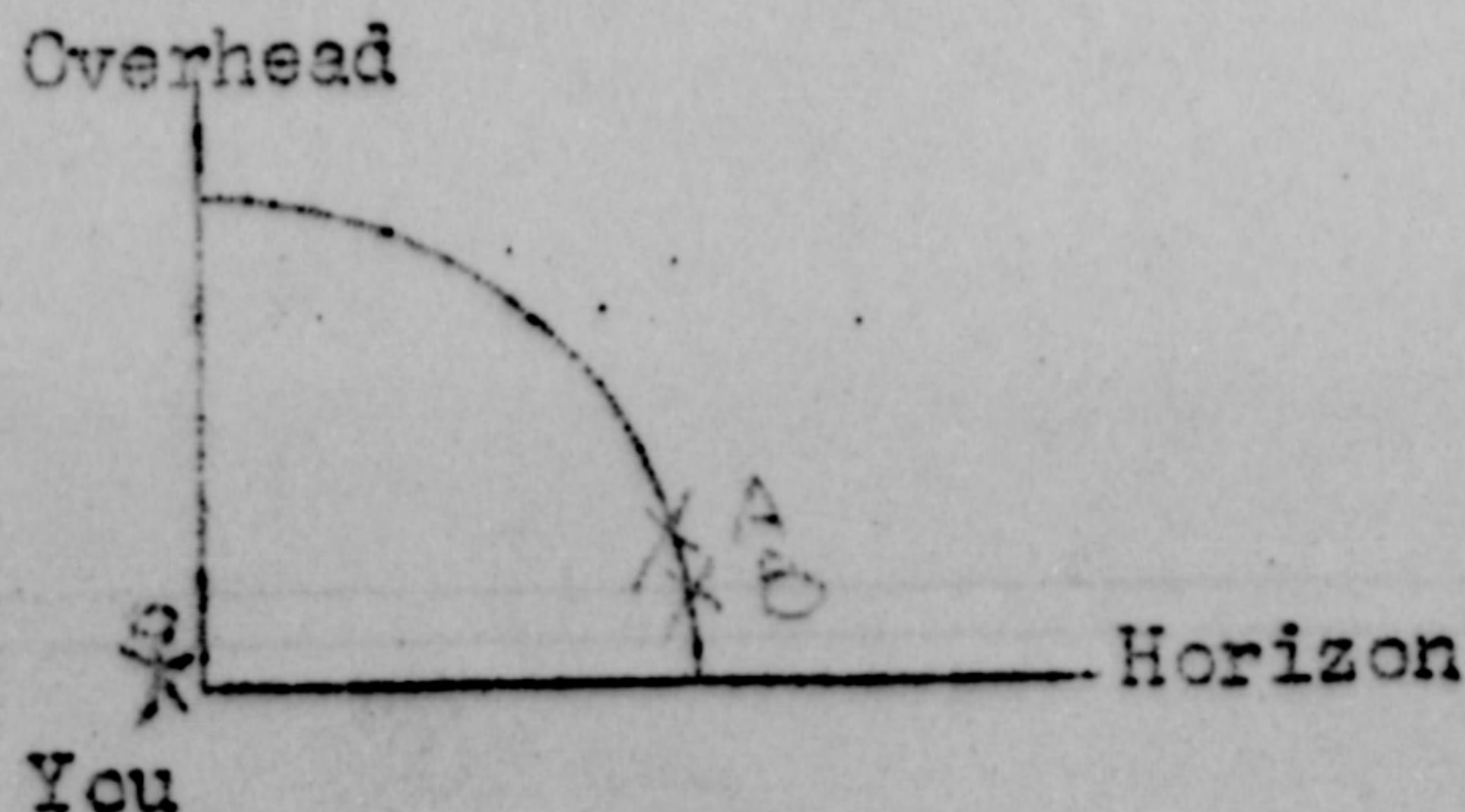

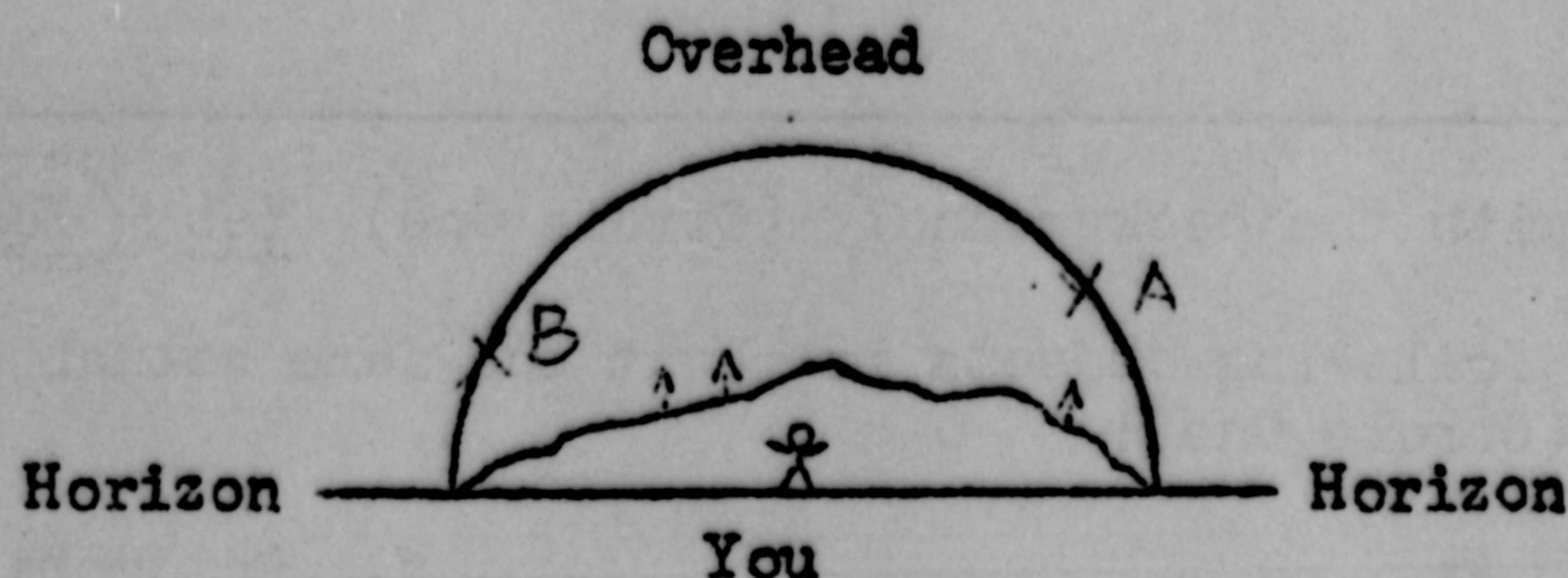

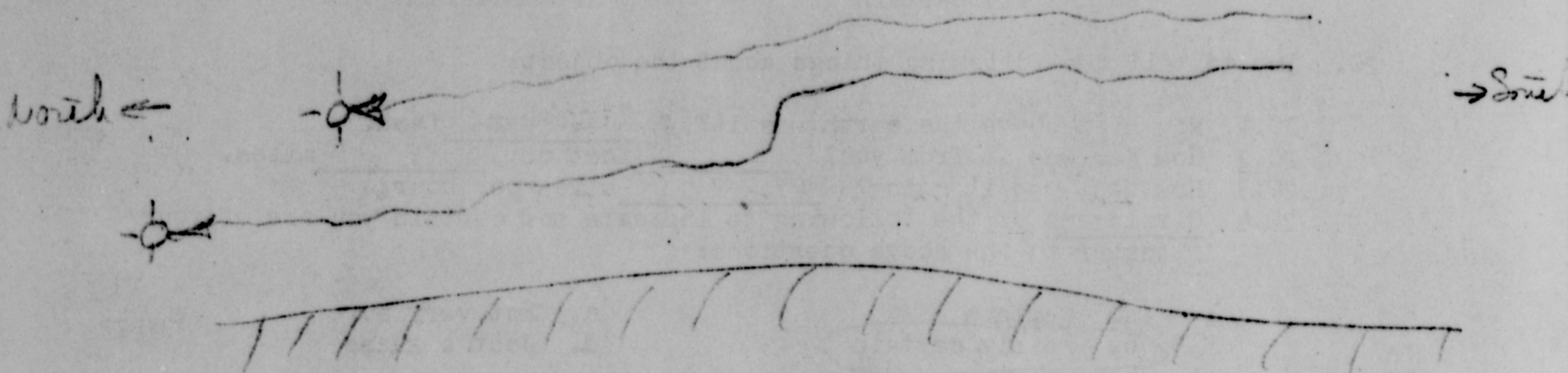

This Office received the enclosed correspondence concerning the observation of an unidentified flying object from Mr. [REDACTED].

Since the subject letter includes great detail, the correspondence should suffice in presenting the facts surrounding the observation and will not be elaborated upon in this report.

The only additional information that this Office can supply is that the weather at the time of the observation may be described as 7-mile visibility with high scattered formation. There were no military or civilian aircraft reported to be in the area at the time; however, this is not conclusive proof that aircraft were not in the vicinity. Civilian authorities at Harrisburg State Airport indicated that weather balloons had been released some time earlier, disclaiming the probability that they were in the observer's area at the time.

This Office can offer no definite explanation for the sighting.

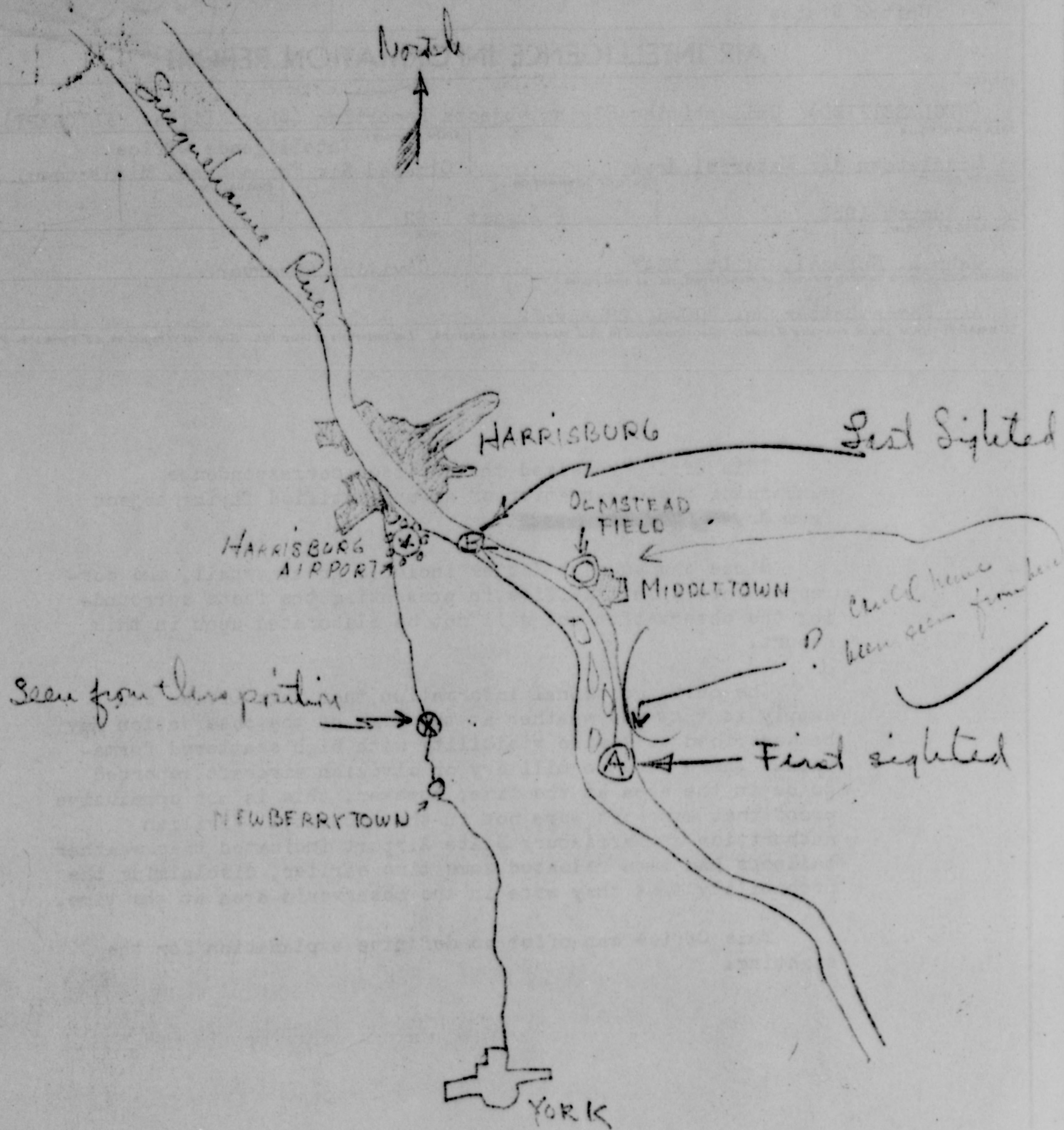

Dear Lieutenant Speigel:

I understand from our local paper that the Army Air Force is requesting all observations of "unidentified flying objects" to be reported to them.

On the following pages you will find a detailed description of such a sighting as viewed by myself and family on the 28th of July at 11:05 P. M.

I personally feel that many reported accounts are highly erroneous and can easily be explained by the activity of local aircraft, searchlights, etc. It may well be that such will be the case in this instance and I have therefor added pertinent questions which, if you investigate, should eliminate such possibilities or prove our observations to be of a character easily explained.

For your further information it is my opinion that many observations or sightings have been made by people not specifically qualified to report even the conditions surrounding such observations. I am therefor listing my background so that you may judge thereby the probable accuracy of my report.

My own conclusions are that the objects sighted were definitely not reflections of ground objects due to a temperature inversion.

They were furthermore not reflections on the glass windows of the car in which I was travelling but stopped for observation and got out of same.

They were too bright for identification lights on planes.

REPORT OF SIGHTING

Date - July 28th, 1952

Time - First seen about 11:01 P. M. Last seen at 11:08 P. M. when I moved car to spot just North of Newberrytown and they were no longer visible.

Place first seen - About 2 $\frac{1}{2}$  Miles North of Newberrytown on Susquehanna Trail (1 mile from end of present four lane road). Drove one mile in about one minute while watching lights and stopped car. Objects did not seem to be moving in sky. (Note that this car movement provides a triangulation base for estimated distance noted later). Next observations made after stopping car and getting out of same about one mile North of Newberrytown.

Estimated Line of Flight - Probably first sighted over Susquehanna River in vicinity of Goldsboro and last saw them in vicinity of Highspire.

Estimated Altitude - Between one and two thousand.

Estimated Speed - Visually they gave the appearance of travelling at about 80 or 90 MPH.

Estimated Distance - Three to Four Miles.

Description of objects - They consisted of two (2), very constant intensity, sources of light with an estimated intensity of approximately eight to ten times the magnitude of brightness of the North Star on a clear night. The color was in the pink part of the spectrum, perhaps due to haze. There were two of these lights separated at an estimated eighth mile with the one to the rear slightly higher in elevation than the lead object. The lead object descended somewhat when passing the sky glow from Olmstead Field.

No smoke trail or light rays were otherwise visible near the lights. Their speed was relatively constant. The objects seemed to be affected by thermal up-drafts and down-drafts. My oldest son made this observation which corroborated my own without any prompting or previous mention of the fact on my part.


There were no red port lights visible which should have been the case if they were planes.

The intensity of these two lights did not change which they would definitely have done had they been tail lights on two planes travelling thru the arc they seemed to describe.

Atmospheric Conditions - Slight haze with ceiling estimated at 2,000. One very definite local thunderstorm to East of Olmstead Field a more lightning sighted to North and more to West. I made a definite effort to obtain a visual image or outline of these objects when lightning strokes illumined the sky in back of them. I could see no physical outline of any object however in spite of my experience at this sort of thing in hi-speed photography.

Report of Sighting - (Cont'd.) -


After moving the car to a spot just slightly to the South of Newberrytown (On York Haven Road) the objects were no longer visible and the storm to the West of us came in with heavy rain. A commercial airliner or Armed Forces plane with blinking lights (identification lights) was observed flying South East and the relative intensity of the lights before mentioned noted to be at least 5 times that of the white tail light. I estimated the distance of the aircraft at about half that of the two previous lights.

To check these observations I would like to see the following questions answered:

1. Did any planes land at Olmstead between 11:08 and 11:15 and in particular ships with low cruising speeds?
2. Did the Harrisburg Airport land two planes between 11:08 and 11:30 which came in from the East?
3. If your search radar was in operation did it pick up these objects?

If the first two questions are negative my own conclusions would eliminate the possibility of light planes because of the severe local storms and the lateness of the hour.

If your search radar picked them up and received no answer on interrogation it would further corroborate the presence of some definite objects of abnormal character.
