1. On the night of 16 April 1954 Mr. [REDACTED] observed an unusual flying object in the air. Interrogation of Mr. [REDACTED] by PACD Intelligence Officer revealed the following information:

a. While at Sandy Beach which is located on the southeast shore of Oahu on 16 April 1954 between 2215 and 2220 hours, Hawaiian Standard time, Mr. [REDACTED] observed a brilliant red light-like object hovering over the ocean between Oahu and Lanai at approximately 3,000 to 4,000 feet elevation.

b. This brilliant red light-like object remained stationary for about one and one-half minutes, then continued at a very high rate of speed in the direction of the Kaneohe Marine Corps Air Station. While the object was moving at this rate of speed, a tail of light (like a neon sign) was observed.

c. The U. S. Weather Station at Honolulu International Airport revealed that the weather on the night of 16 April was very good with wind direction north-east at 10 to 12 knots. No ceiling and visibility was very good.

Comment: Pearl Harbor Rescue checked and reported that no aircraft or ships were reported in that area at that time. Kaneohe Marine Corps Air Station reported that a C-45 landed at their station at 2230 hours on the 16th of April. The radar station at Kaneohe was contacted by phone but nothing unusual was reported on the night of 16 April. No substantiating reports from other military and civilian agencies were received that would confirm the above reported sighting.
