During the investigation I contacted the 117th AC&W unit at Travis Field, The Savannah Filter Center, the Weather Bureau at Travis Field, The Weather Officer at Hunter AFB, Tower Operations Officer at Hunter AFB and at Travis Field, Air Operations Officer of Air National Guard at Travis Field and The Radio Controlled Aerial Targets Section at Camp Stewart, Georgia, none of which had seen the reported unidentified object or could account for same. Therefore, I as preparing officer am unable to determine what the object was or could have been.

The characteristics of the second object were the same as the first. 



Local Man Sees Mysterious Object In Nighttime Skies Over This Area

"It had a reddish tinge and was about the color of the planet Mars," said Frank Saunders in describing a mysterious object which he saw in local skies at 8:24 p. m. Tuesday.

Saunders, who lives at Roanoke Motor Court, said the object did not blink nor did it make a sound that he could hear.

"It was faster than an airplane, but slower than any meteor I've ever seen," Saunders told Radio Station WCBT's news department shortly after the occurrence.

He said he spotted it in the East, that it moved from East to West past the zenith, then turned South to about what he called "11 o'clock", then West again and he lost sight of it. He had it under observation for about two minutes.

He said that as he observed it, it moved "about one inch per second" in his visibility.
