COMMENTS As highway in front of house, and objects (lights) rptd slightly off the ground, UFO's undoubtedly were auto lights. Aerial obj could not have gotten between trees in front of house as source claims of objects. A previous check with State Highway patrol discloses there was a police patrol on the highway to prevent theft of construction material. Police make extensive use of spotlights. Note speed rptd (20 mph), general auto cruising speed.


