


10. BRIEF SUMMARY OF SIGHTING A round to crescent shaped object, orange in color, was sighted in the East just above the horizon. The three pilots were of the opinion object was the moon. However, obj supposedly picked up on ground radar also.				11. COMMENTS The moon was approaching 1/4 (first quarter) on 14th, sighting on 11th. Direction of obj and moon coincide. No witness indicated seeing obj & moon at same time. WX inversion probably present. Same inversion distorting moon would cause spurious radar returns from WX or ground objects. The pilots no doubt saw the moon. The radar paint was probably caused by effects of inversion which distorted visual obsvation of moon.

SUBJECT Unidentified Flying Object Report

Begin text of report on AF Form 112a.) <p>An unidentified flying object was sighted on 12/0300Z approximately over Parkersburg, Ohio. Airborne sighting was by Avenger White flight, 3 F-86L's, out of Lockbourne AFB, Ohio. Ground sighting was on search radar by the intercept controller at 783rd ACWRON, Guthrie, West Virginia. Reports indicate that the object was almost circular and was an orange color. The pilots report that the object did not move and only change appeared to be in range. However, the object moved erratically on the radar scope and was estimated at a speed of mach 1.5. It remained in sight from 20 to 30 minutes.</p> <p>It is possible that the pilot sighting was the moon and that radar return was from a low flying aircraft or radar noise. Correlation between radar observed position and pilot sighting indicate otherwise.</p>

10. Location of any air traffic in the area at the time of sighting: Lockbourne AFB, operations stated that several B-47's landed shortly after 0400Z, 12 Dec 57, and were possibly in the local area for a period of time before landing.

11. Position Title and Comments of the Preparing Officer, including his preliminary analysis of the possible cause of the sighting: Lt Wayne A. Rhoades, Senior Director.

Airborne sighting was by Avenger White flight, 3 F86L's. UFOB was first observed when White 3 noticed orange glowing object at one o'clock position. He was 20 miles west of Parkersburg, Ohio heading 090° at 25,000 feet climbing. He was informed that the moon was up and that it could be the moon. He said it was not. At that time we spotted a radar blip 10 miles east of Parkersburg moving toward the flight at estimated 1.5 mach. Movement was erratic, sometimes hovering, then resuming speed. As it neared flight, pilot and radar position reports agreed, and pilot said object was crescent shaped, orange-red and glowing. Object on radar appeared to join flight at Parkersburg. Its radar appearance was less intense than that of an aircraft and it faded from time to time.

Flight turned north, then northwest to Lockbourne. Last radar contact was 20 miles north of Parkersburg. Last pilot contact was 30 miles south of Lockbourne. Pilot was heading 350°. Object was following in 5 o'clock position.

It is possible that pilot sighting was the moon and that radar return was from a low-flying aircraft or radar noise. Correlation between radar observed position and pilot sighting indicate otherwise.

11 December 57

" 2210 - Received call from Capt Lybarger, Op's Officer Flight Services, 2046th AACS. Lybarger stated that he had received a UFOB Report and will send to ATIC."

12 December 57

" 0100 - Received call from 58th Air Division, Capt Podvosjki, Senior Controller, who stated that he received report from two fighter aircraft, radar equipped, that they had picked up an object on their scopes, est. speed Mach 1.5. Also stated object chased aircraft. All this over Charleston, West Virginia. Aircraft from Lockburn. Report is being sent ATIC but Capt Podvosjki states that full description not in report. Suggest 58th Air Division be contacted soonest."
