UFO Sightings, State of Washington

SAFOI-3d (Maj L. J. Tacker)

1. It was brought to the attention of ATIC by Congressman [REDACTED], State of Washington, that during July and August of 1959, there were a number of sightings of unidentified flying objects in the areas of Bremerton, Yakima, Bellingham, and Hoquiam, Washington.
2. These objects were described as red, green, white, blue, and yellow by the various witnesses; all sightings occurring at night.
3. ATIC contacted the 25th Air Division, McChord AFB, Washington and requested an investigation of these sightings. The Directorate of Intelligence of the 25th Air Division informed ATIC on 15 September 1959, that these lights resulted from flares emanating from known friendly sources. A telephone call to the base commander, McChord AFB, Washington determined that these friendly sources were SAC aircraft conducting a refueling mission in the area.
