OBJECT DISAPPEARED GRADUALLY OVER HORIZON TO THE WEST ASI FLYING OUT OF RANGE OF VISION OF NAKED EYE. OBJECT PROCEEDED IN GENERALLY STRAIGHT PATH ACROSS SKY EXCEPT THAT IT APPEARED TO BE TURNING OR ROTATING IN SMALL ARCS THROUGHOUT COURSE OF TRAVEL. NOTHER WITNESSES OBSERVED THE OBJECT EXCEPT MRS. [REDACTED] HUSBAND WHO WAS PRESENT AT THE SAME TIME. HE HAS NO ADDITIONAL INFORMATION.
