1. A report of civilian sighting of unidentified flying objects is submitted in accordance with AFR 200-2.

a. Description of Object:

- (1) Round.
- (2) Match-head held at arms length.
- (3) Blue cast.
- (4) Two first sighted then the third appeared.
- (5) Trail formation.
- (6) No detail visible.
- (7) No trails, etc.
- (8) No noise or sounds heard.

b. Description of Course:

- (1) The bright lights in the sky commanded observer's attention.
- (2) 30 to 40 degree elevation of first sighting.
- (3) 25 degrees.
- (4) Traveled South, Southwest then disappeared moving Southeast.
- (5) Behind trees to the Southwest.

c. Manner of Observation:

- (1) Ground, visual.
- (2) No optical aids used.
- (3) N/A.

d. Time and Date of Sighting:

(1) 0700Z, 26 September 1959.

(2) Night.

e. Location of Observer: Adna, Washington, $46^{\circ} 38' N$, $123^{\circ} 03' W$.

j. Three airline flights are known to have passed approximately
15 miles East of the observer's position and are known to have been
in this area between 0700Z and 0730Z.

k. Report prepared by Captain Eugene G. Smith, 41404A, Assistant
Operations Officer, 337th Fighter Group.

(1) The report of the unidentified objects did not reach this
office until four days after the alleged sighting. The report was first
received from a Mr. ██████████ who was informed of the occurrence by
Mr. ██████████ Captain Smith contacted Mr. ██████████ by telephone to verify
the report.

(2) There are numerous airline flights along airways that pass overhead and 15 miles East of the observer's position. As stated in paragraph 1j, three airline flights are known to have been in this area between 0700Z and 0730Z from records retained by Portland FAA Tower on IFR traffic routings. There are no records to indicate the number or position of aircraft on VFR flights in this vicinity.

(3) Although there is no evidence as to what the observer saw, it is believed that Mr. [REDACTED] could have seen lights from a commercial aircraft and mistook them for unknown flying objects.
