Dear Mr. Rice:

Since I can not get any direct information to who should receive the following information, I must send it to you in the hope you will direct it to the proper channels.


Last Monday night, approximately midnight, I noticed what I thought was a plane in distress in a general direction from my bedroom, north by northwest. The light which first attracted my attention was of a flickering blue=white intensity. The craft - if it was a craft - maneuvered rapidly and at times grew to full magnitude, the flickering incandescence becoming intense and steady. At first, I decided it might be a jet since they do make lights of varying colors. The light - the first one I noticed and at the time the only one, I believed - did what is commonly known as a figure '8'. It was this maneuver which made me think the light might be coming from an ordinary craft. Later, approximately one a.m., this one blue-white light was joined by another of an orange-yellowish-white intensity. The two maneuvered together, first up into the heavens at tremendous bursts of speed, far greater than any jet I had ever

She also said nobody, to her knowledge, has tried to study them through high powered glasses or has tried to get a fix on their possible position. She also said at times in the past five years, a single light of a whitish cast has appeared over the eastern ridge behind her home, has remained stationary for hours before it slowly moved off in an easterly direction. At the time, she was connected with Civil Defense and made inquiry through that channel. She said so far as she knows, nothing was ever done about it.

seen in flight; coming to an almost dead halt, then ranging down the heavens in equally great bursts, not - or so it seemed to me - slowing but coming to slower speed immediately. Still later, I noticed a group of these lights behind these two. They also were of the same coloring as the other two with the exception of the one - which told me they were not stars - moving off by itself in spurts. Its movement reminded me of some object magnetized, being jerked across the heavens. This one swung around until it faced approximately due west from where I stood. It grew from a lack-lustre orange-white to a brilliant blue-white.

In all this maneuvering, there was absolutely no sound.



The other peculiar thing was these two foremost ones which gave off an incandescent powderish something that floated loose and free, not as contrails. Whatever the stuff was, it vanished within seconds of release.

At dawn - I watched this display until then and lost them - I made a mental check of approximately how high they might have been. Behind my bedroom are three telephone wires. At an angle from my bed, where I first spotted them after the electric lights were out, at approximately a 40 degree slant upward and gauged from the ridge over which they seemed to be, I'd say they were approximately 60 to 70 miles high, maybe higher.

When I first noticed them, they were in a string, like beads. Later, the blue-white one began to do figure '8's. I have made diligent inquiry upon possible airstrips in or near this sections. There aren't any, I'm told.

I have been informed by [REDACTED] that these lights have been seen over a course of three to five years back.

Forward view appeared as heat reflector or mirror for gathering solar energy. Since it is fairly known sun gives off vari-colored solar energy bands which have also been detected in the radio, TV, and other ranges; ship would be constructed minus metals for attraction to detrimental circuits; possibly laminated; sealed in much the same manner as a-bomb was constructed; removing some component so that balance (lack of balance) would cause ingredients to adhere. Of a mirror-type either round or pear-shaped traveling on some known magnetic band; either boosted by solar station already in space (mother ship) or boosted through full knowledge of employed magnetic band from sun.

This one hung suspended east of my window for at least 30 to 45 minutes. It did no gyrations, just hung there. After a period of time, it slowly began to recede back toward where the blue-white one was still doing circles and dives in the west. It did not - or seemed not to from its diminishing size - stop or slow or in any manner attach itself to the blue-white one. It continued, if diminishing size is any factor, until it became impossible to track. It went in the general direction of the string of lights, though I could not possibly say it became part of the string.

The blue-white one continued various passes until I lost it in the coming light of dawn.

While the details were fresh in my mind, I measured the distance - on that slant - from the base of my window, representing horizon, to the top of that high tension wire. It measured eleven inches.

Still later, I called ex-Commander (USN) [REDACTED] who lives in this area, and asked him, after fullest description of what I had seen and done, if such a measurement might give their approximate height. Mr. [REDACTED] said I might conclude that one inch of space would roughly equal 10 miles. If this is so, then the objects were 110 miles high.

Upon my description of time it took the second one to recede, Mr. [REDACTED] ventured the speed of 8 to 10 miles per second.

I was first attracted to the blue-white flickering light because I believed it was a shooting star. But when it leveled off (see frame one) and started its slow approach toward the 'toe' of the loop, I then figured it must be a plane in distress. Therefore, I opened my windows to try to gauge by noise how far away the plane might be.

Whatever it was, it was extremely high. Behind my room - I had turned off the lights long before this as I was ready for bed - crossing an open field at a higher elevation than my window was a high tension phone wire. It was about on a 40 to 45 degree slant from my window. I noticed the wire only when the flickering light seemed to "ride" along the top of that wire.

The light continued its maneuvers, at times surging with blinding speed up toward zenith, making a few lazy circles before it plunged back down again. There was no "shadow" such as would have been had this object been a plane, the bulk of the plane often blotting out exhaust flame as it turns. There was a definite sense the light was turning, but there was no blotting out of the light itself.


How long it continued its maneuvers, I cannot say. But sometime later, a second joined it in its runs. This one appeared to have a seething white base with a very thin cherry tinted veil over its face. (The nearest I can describe this second one is to refer you to a steel-making furnace. The steel in its molten form is nearly blinding white, but it hold that peculiar cherry "veil" over its surface.)

This second one, after a few passes with the flickering one, suddenly began to expand. It grew from pea size - held at arm's length - to tennis ball size, held at arm's length. It was not round as a tennis ball; built more like an apple if the stem were pointed down. It seemed to have - it looked so to me - two holes, one on each side of its front, not directly straight out from the front but more to the side. (Since searching for a description to fit what I saw, I refer you to the muzzle of a cow, the holes placed just about like the nostril holes of a cow). As it ~~was~~ expanded, it lost its cherry veil, the white growing to an almost "eye-hurting" dazzle. It traveled from due west across the face of the heavens, facing south, to due east. As it traveled, something was released from it.


It was not smoke or did it resemble contrails. As near as I can judge, the stuff released floated in a lazy "S" fashion, glittered like it might contain glass - ground or otherwise - stayed visible no more than two seconds at the most.





