The following, extracted from Lt Brooks' Report dated 25 June 1950, is quoted for your information.

Subject: Two UFO Reports

1. Col. Gensen (26th Air Division D.I., Syracuse, Clenvview 8-5500, ext 468) reported a UFO and described the two samples he obtained:

a. A peice of material, maximum dimension 6 inches, light in weight as a sponge.

b. A lemon shaped piece of very light metal.
Complete report will follow by wire.

2. This information came from the British West Indies Airlines through NORAD, then through the AF Command Post (WPAFB, Maj Nebbal). At 26/0207Z a Britiah Viscount Airlines enroute from San Jan Puerto Rico to Barbadas spotted a bright white object with a green center which disintegrated into a green colored object.

This report was received at 2340EST 25 Jun.
