I take pleasure in sending you some information I believe will be of great help to you, as well as a suggestion.

Approximately six months ago I was lying down, resting - on a clear and sunny day with a beautiful blue sky - when I looked through the window and saw, in the sky, at a considerable distance, an object in space, of the shape of a very large star. It had a brilliant platinum color. From it was suspended a tail or track and at the end it had a red ticket [? - "boleto"] which could be noted at a great distance. I sat up to observe it and followed it with my eyes. It continued to rise to a high altitude until it was lost from sight. There were no clouds. The sky was clear and brilliant. I am sending you this information for your study and consideration.

The suggestion I want to make pertains to how your government can save millions of dollars which could be used to fortify and prepare your bases and territories. It could suspend the allotments paid to the relatives of soldiers in service in time of peace. I am doing this because I love your great country deeply and I would like to say that my husband is retired, with thirty-three years of service.
