Light conditions were just before dawn. Moon was beginning to appear (rising).	9. COURSE <u>on moon</u>	11. COMMENTS Moon was at 10.12021 RA /at 0300 & 10.14.19 at 0400. Declination was between 13.23 & 13.14. Position was very close to Regulus at this time. Regulus was at 10 with a declination of 13. Possibly a mirage associated with the star Regulus and the Moon or possibly the refraction of the moon itself prior to it's rising, in any case, the sighting was due to the moon's rising and the optical conditions present
