SUBJECT: Reply to Letter from Mr. [REDACTED]

Following is suggested draft of reply to [REDACTED]  
concerning two objects he and [REDACTED] observed over  
St. Clair County, Alabama:

"Dear [REDACTED]:

This is in reply to your letter of recent date  
in which you reported seeing two unusual objects in the  
sky over St. Clair County last spring.

Thank you for reporting this observation to  
the U.S. Government. What you saw was probably the  
re-entry of two test vehicles, sent aloft by one of our  
bases to test the metal on a missile or for some other  
purpose which made it necessary to recover the capsule,  
and therefore parachutes were used to slow the vehicle  
down so it would not be damaged on landing.

Since no base in the area reported it as an  
Unidentified Flying Object, it would appear that they  
were aware of the test.

We are inclosing, for your information, a  
Fact Sheet which has recently been compiled by the Air  
Force on the subject of Unidentified Flying Objects and  
Unusual Aerial Phenomena. It is believed that this Fact  
Sheet will be of interest to you and will help to explain  
the Air Force program for the investigation and evaluation  
of reports of this nature.






Upon request, from you, if you wish, I will send you a diagram of just what we saw and how it happened. They were not shaped like fighter planes or the sort, but more like a rocket type ship.

This happened over "St. Clair County" Alabama. Which is about 35 miles from Huntsville Space Center. That is the direction they went, when they re-entered.

I definitely do not doubt what we saw! We have not discussed it to others. Only between ourselves. And when we saw it, we immediately knew what we saw, was to-re-entries of some sort of rocket planes or rockets.

Enclosed; you will find some pictures of a project at a school where I was co-ordinator. I received a picture (11 x 14) from Ralph Dungan of the President to present to this school. Many people hated my gutts for this. Wasn't that pathetic?"
