K(1) LT. R.R. WEVER, WEAPONS DIRECTOR WHO QUERIED THE F-89 PILOTS REGARDING THE SIGHTING. LT. WEBER IS IN AGREEMENT WITH THE PILOT'S ASSESSMENT. THE F-89 PILOT

INSISTED THAT IT WAS AN OBJECT ENTERING THE ATMOSPHERE AND DISINTEGRATING. HE COULD SEE PARTS FALLING OFF VERY CLEARLY AND THAT THEY NEVER CAME CLOSE TO THE GROUND. BOTH PILOTS AND RADAR OPERATORS WERE IN AN EXCELLENT POSITION TO SEE AS THEY WERE AT 10,000'. ALL FOUR AIRCREW MEMBERS OBSERVED AND STATED THAT THE OBJECT'S NEAR VERTICAL DECENT GAVE THE APPEARANCE OF HOVERING.
