


NOTE - [REDACTED] reported object was moving from NW & then went toward North. It made a sharp turn toward EAST & finally disappeared behind buildings on horizon. Object moved in a "jerky" manner and did not follow a definite path as would a satellite. Movement appeared too jerky for aircraft & turns appeared too sharp. Object appeared at high altitude higher than a B-52 would appear at about 40,000ft" (subject's own comparison). Object brighter than stars. He indicated there were about 3 or more witnesses with him
