

13 Aug 1965

Report received 1045 hours from Mr. ██████████, age 37 ██████████, Baden, Pa. approximately 20 miles NW of Pgh. Mr. ██████████ was returning to the house from his garage when the sighting occurred. The sky was clear and the moon full. As he turned up the walk, he was suddenly aware that the moon was obscured. Turning around he states that he saw a Disc Shaped Craft about 300 feet in diameter at an altitude of about 300 feet. The object was traveling almost due north at approx 50 MPH. He described the disc as being surrounded by orange lights. His guess being between 200 and 250 of them. The lights were stationary. As the UFO moved away, he noticed a blue light coming on at the bottom and the center of the UFO. As this happened, the orange lights around the circumfrance dimmed. Mr. ██████████ stated that the light at first had the appearance of being ultra-violet then got brighter until it was bright blue. The blue light lasted for about three seconds then went out along with the orange lights. At this same time he experienced what he said was a "shock wave." He felt a force which almost knocked him down and noticed the leaves on the trees rustling. There was no natural wind at the time. He then ran into the house and phoned the Air Force. About 20 minutes later he experienced severe burning of his eyes and hazy vision. Gradually he lost sight in both eyes. When he was contacted by the Inspecting Officer once again at 1745 hours he had no vision in his right eye and hazy vision in his left eye. He said that the whites of his eyes had turned red. He also stated that his entire body felt "Sunburned" although he has a deep natural tan. The Doctor examining him said that Mr. ██████████ was suffering from an "Arc Welding" type burn. This would indicate the presence of ultra-violet rays. He said he has not done any welding in many months. The entire sighting took place in about 20 seconds and at the time the blue light came on, the UFO was about one half mile away. There was no sound emitted by the UFO.

13 Aug 65

Report rec'd from ██████████, Darson Ridge, Beaver, Pa. several miles north of Baden, Pa. The UFO was sighted 0100 - 0140 hours. Weather conditions were clear, full moon, no wind. Altitude of the UFO from one half to three quarters of a mile high. Direction uncertain. The color was white, except when hovering, then red and blue lights appeared and revolved, first clockwise then counter clockwise. The shape of the UFO was circular. Object seemed to rise and fall. At one point the object gave off a white streak of smoke which shot straight up. Mr. ██████████, age 30, is employed as a toll collector for the Penna Turnpike Commission. He said that he has been interested in UFO's for some time. He had one previous sighting several days previous to this. He has photo's taken by someone else in the area and same were published in the local newspaper. After watching the above described UFO for 35 minutes or so he went into the house, looked for it later but it had disappeared.

SUMMARY REPORTING OFFICER: The individual contacted who took photo's of a previous UFO in the Beaver area is Mr. [REDACTED] Lucci, Gypsy Glen, Brighton Twp. Mr. Lucci's brother John and a friend Mr. [REDACTED] Darson Ridge were also present when the photo was taken. The negative was given to the Beaver Valley Times and an article and the photo were released to the public by the Beaver Valley Times. Mr. [REDACTED] does not wish to give the negative to the Air Force at this time. The camera used was a Yashika 635, Twin lens reflex f3.5, 80mm blue coated, Copal MXV lens, 120 film altipan 21 Lumiere Rapid, 6x9 cm. Developed in Dektol 76 solution. The individual taking the picture has a dark boom at his residence. The lens was open six to eight seconds and the camera took the picture from a tripod. At the time the UFO appeared, Mr. [REDACTED] was taking pictures of the moon. That was his original intention.

29 Aug 65

Report of UFO received from Mrs. [REDACTED], [REDACTED] Drive, Pitcairn, Pa. 15140, (Tel. [REDACTED]). Mrs. [REDACTED] observed a white disc shaped object at 1050 hours moving across the sky. There was just one object which was round and seemed larger than commercial planes which fly over the area, about the size of a half dollar, moving very fast, SW to NE. There was no sound. Object was seen when Mrs. [REDACTED] opened her living room window to see the sky and clouds. The sky was clear, blue and there were some fluffy white clouds. Object was below the clouds. The clouds were not moving but were stationary. Mrs. [REDACTED] lives on a hill overlooking the country and the object was flying low to the horizon. Mrs. [REDACTED] can see the sky well, raising her head at about a 45 degree angle. The object was seen for about 10 seconds.

31 Aug 65

Reference sighting by Mr. [REDACTED] Baden, Pa. (T. [REDACTED], 13 Aug 65. Dr. [REDACTED], Pittsburgh, Pa. [REDACTED] was contacted. Dr. [REDACTED] stated that to date no final evaluation on Mr. [REDACTED] eyes had been made. However, he did state that there had been some vision drop in one eye and a slight hemorrhage in the other eye which is rather hard to explain and possibly not truly a hemorrhage and does not look like radiation burn. Further studies are being made. Dr. Linn saw Mr. [REDACTED] one week after the situation happened.

30 Aug 65

Report received from Mrs. [REDACTED] Penn Hills [REDACTED] stating she had seen a glowing man or diamond in her back yard between 0100 - 0130 hrs. When she saw it, it was lying down in some bushes at the back of her yard. She saw it for about one minute when she looked out of the window. The object was brought to her attention by two young boys. [REDACTED] who lives on [REDACTED] Penn Hills, age 14, who was visiting [REDACTED]er, age 18, who lives upstairs at Mrs. [REDACTED]s residence. [REDACTED] saw the object when he was going home and went back to ask his friend [REDACTED] to walk him home. They threw objects at it and as they started to leave, it took a step toward them. The boys ran in opposite directions. [REDACTED] described it as being 8 feet tall with a bright gold glow. After [REDACTED] ran home he asked a friend to go back and when they did, with the aid of a flash light, they found nothing. [REDACTED] stated he saw the object for about 15 to 30 seconds. Mrs. [REDACTED] stated the ground and weeds in the area she saw the object were flattened down when she checked the area later.

(Possibly this could have some type of swamp fire and when I asked what type brush and if there was rotten wood in the area, Mrs. [REDACTED] didn't know.)

FLYING SAUCER FROM MARS DISCOVERED

An on-the-spot Institute investigation recently verified the existence of a "Flying Saucer From Mars," which has accounted for many UFO sightings in the Pittsburgh area. The object is a Citabria Champion advertising plane flown by Fred Eiler, Culmerville Airport, and bears the above quoted inscription with the qualification "Pa." in small letters after "Mars." Mr. Eiler owns AAA Sky Adds, Inc.

The wingspan of the Citabria ("airbatic" spelled backwards) is 36-1/2 feet. It usually flies at an altitude of about 1,000 feet, around 70 mph, and can stay aloft over five hours. Mounted below the wings is a framework of wires to which are soldered 7 rows of 36 CMSI bulbs, the size of a flashlight bulb. A heavy tape with holes punched in it to spell out a message, runs through a machine inside the plane which makes the bulbs light up in a certain sequence, to make the message move across the lights. An air siren mounted below the plane is sometimes used to attract attention.

In a strong headwind, at an airspeed of 30 mph, the Citabria can appear to be standing still. Seen on edge, its lights, moving from one side to another, can give the appearance of a flattish object with a row of lights around the rim. The engine of the plane is inaudible at a distance from which the moving lights can be easily seen; thus, many people report seeing a silent, disc-shaped object with a rotating rim covered by equally-spaced lights. When the plane is flying directly toward or away from the observer, especially in a misty atmosphere, its appearance can be quite eerie. It can, as several reports have stated, definitely "not resemble any conventional aircraft"!
