




It was about 2 a.m., the sky was clear and the scene bright with moonlight, when Penrith angler Thomas A. Bell (who is also a member of the Royal Observer Corps) saw what he called a 'flying cigar' while he was fishing the Eamont at Pokey Dubs.

According to the *Cumberland Evening News* of August 12 (the date of the sighting), the object travelled swiftly over nearby trees towards the South West, emitting an orange-coloured flame or sparks at the rear. Mr. Bell could hear no sound, but he did say that the nearby railway line was busy.

Mr. D. W. Hutton relates in a letter how he, and a large number of spectators at the pre-season trial soccer match, Carlisle United v. Bury on August 13, watched an unusual sky object. The time was between 8.40 and 9.20 p.m. "It was a brilliant white," says Mr. Hutton, "about 50 per cent brighter than Venus, at an elevation of about 35°, and stationary in the South West." The next day

our correspondent was playing cricket in West Cumberland, and was surprised to find that the same object was seen by many people in Whitehaven and Cockermouth, and at the same time in the evening. To them it was almost overhead, and stationary.

"A remarkable plastic bag filled with gas," remarks Mr. Hutton, thinking no doubt of the statement about this incident made by a spokesman of St. Joseph's College Observatory, Dumfries.

LITTLE MEN SEEN IN WASHINGTON STATE: Two girls living in Renton, Washington told state police on August 13th that they had seen three non-human men, about five feet tall, who approached them from a bean field. The incident occurred in broad daylight, at about 7:30 a.m.

As the girls alighted from their car, their attention was drawn by the strange dress, white-domed heads, and protruding eyes of the individuals. The faces had no expression, the eyes were gray like stone, and the lower part of the faces appeared to be very tanned. The creatures wore purple armless V-necked jerseys with white shirts underneath.

The girls ran about fifty feet past the three beings, and when they looked back, all of them had disappeared. No saucer was seen in connection with this strange incident.

PENNSYLVANIA PILOT CHASES UFO: An interesting article dated August 13th tells of a veteran pilot who was flying from Kennedy International Airport to Hazelton, Pa. on a chartered flight, when he spotted a mysterious bright white light. His attention had already been called to the UFO by the control tower at Wilkes-Barre, Pa. The pilot, named Ray Hoffman, maneuvered his plane in such a way as to head straight toward the object. He was within about five miles of it when it veered to one side and sped off toward the northeast at a speed estimated to be two or three times the 230 miles per hour that his small plane was traveling. Hoffman told newsmen that he was unable to close the gap between his plane and the object, which was out of sight within a few minutes. He discounted the idea that it could have been any kind of reflection.

Hoffman is the owner and operator of the Shamokin Flying Service, at Shamokin, Pa. He has been flying since 1934, and is known to be a stable and reliable person.

BACKGROUND:

News of the sighting and the names of the witnesses were given me by one of my brothers who is employed by Nissen Baking Corporation.

SIGHTING ACCOUNT:

Donald O'Leary was gazing at the sky through a large open window facing the northeast during a work-break. Suddenly a noiseless white globe of light with a reddish tint appeared from over the building he was in and moved slowly into the northeast from the northwest on a downward 45° trajectory. At first he thought that it was a huge meteor but it did not disintegrate so he ran to get others to look at it. Lester Mitchell arrived in time to get a good look at the object. It was still moving slowly but had changed direction and was heading northward on a low horizontal plane where it disappeared behind trees 1/2 mile away. It was seemingly headed toward 2 large power cable towers about a mile away.

The object was said to have the apparent size of a silver dollar at arm's length and was estimated to be 500 yards from the observer when first seen. Just before disappearing behind the trees it seemed to be the size of a sphere 1/4 the diameter of a full moon. The brightness and shape of the object was compared to the fuzzy round glow of a 60 watt bulb's glowing filament in the daylight at arm's length. Total observing time was between 2-5 minutes. Lester saw it longer as he observed a full minute before running for another witness. The weather was cloudy. One star was visible.

EVALUATION:

I feel that the apparent size of the object was probably exaggerated but nevertheless it must have seemed huge as compared with familiar lights. No engines were heard. It moved slower than an airplane and was compared with the speed of a slow-moving helicopter. On the surface I believe the possibility of aircraft, satellite, balloon, or meteor must be ruled out. This places the object in the realm of a UFO. It is very similar to the bright white object reported by three men working at the Moncton Manufacturing Company at South Hadley Falls on August 4th about 1:25 AM. This case is currently under investigation.



Enclosed are a number of UFO Reports investigated by the NISAP Massachusetts Investigating Subcommittee. Over 40 UFO Reports were received by this subcommittee between early July and mid-August. The majority of these reports were evaluated and found to be a local advertising plane, Echo I & II transits, aircraft seen under unusual lighting conditions and even a large kite carrying a red flare. Other reports were rejected because of insufficient data, witnesses refusing to cooperate and because of our limited resources to investigate reports at a great distance from us entailing travel. Out-of-state reports were completely ignored.

There were several good sightings during this period. Some reports have already been forwarded to NISAP, some are enclosed, and hopefully others will follow. A sample of the identified UFO reports are enclosed. Many of this type never reached the written stage as it would have been just a waste of time.

Martians Watching Australia?

CANBERRA, Australia (AP) A mysterious glowing object — hovering near Canberra Airport while the U.S. Mariner space probe was taking pictures of Mars — has baffled experts in Canberra. Air traffic control officers and other expert aircraft observers said they spotted the object Thursday.

Six members of the traffic control tower crew said it hung suspended at about 5,000 feet for 40 minutes. When the sun glinted off it, it became clearly visible, they said. It disappeared when an air force plane was sent out to identify it.

EXPERTS ARE now wondering if it was coincidence that the object was sighted shortly before nearby Tidbinbilla tracking station was scheduled to pick up Mariner signals. The station had unusual difficulty in locking on to Mariner at the time.

The sighting also came as Goldstone tracking station received irregularities in messages while Mariner was photographing Mars.

Yet another mystery object was observed over Westmorland Pennines, not far from Brough, on August 15. Accounts appeared in the *Yorkshire Post*, *Guardian* and *Daily Express* of August 16, and in other newspapers. Immediately apparent is the fact that some newspapers unabashedly use the name "flying cigar", but the *Daily Express*, cautiously conservative, speaks of a strange "flashing beam in the sky just after midnight, which caused cows and sheep to moan in a weird fashion".

Once again we have a report from Jack Ibson. Said Miss Katherine Chambers, who, like her two friends who were also witnesses, hies from Leeds: "I knew about the Loughrigg, Ambleside object, but the one we saw was definitely not saucer shaped . . .

"My friends and I had gone to bed, and had been talking awhile when I heard a sheep making a most peculiar noise. My friends took little heed, but when we heard cattle also moaning, we really took notice, for this had been reported before. My bed was directly under the window, and despite my friends' protests I knelt up and looked out. The first thing I saw, directly ahead, was a pair of vivid orange lights flashing in the sky. I shouted to my friends to hurry, and, their curiosity overcoming their fear, they joined me."

The object was under observation from about midnight until 1.15 a.m., on August 15. The sky was clear, and moonlit. The report continues: "As my eyes became accustomed to the light I could see a dark shape connecting the orange lights. More frightened than ever, my friends went back to bed, but I continued to watch as the object seemed to move slowly backwards and forwards in the sky, and then changed from a horizontal to a vertical position, with the

Gentlemen:

I recently visited my son, his wife and their child in Englewood, Colorado. I had never met my daughter-in-law and found the visit particularly interesting because it gave me a chance to talk to her about the UFO sighting which she had more than a year ago. I have known about the sighting for some time but didn't have any first hand information about it before this time. She did not report it to anyone but friends and family.

Her name is Mrs. [REDACTED], Englewood, Colorado.

The date of the sighting was between the 15th and 20th of August, 1965, on U.S. 85, between Platteville and Gilcrest, on the highway going from Denver north to Greeley, Colorado. She and her brother were in the car, she was driving and her brother, [REDACTED], 11 at the time of the sighting, was sitting next to her. It was about 9:30 P.M., the night was clear with the moon, not full, in another part of the sky.

Joe saw the UFO first to the east, and it appeared suddenly, it did not move into the area. It was one object, between 30 and 50 feet above the ground, and between 500 yards and 1 mile from their car. The object was golden yellow with a glow below it. The glow was not the color of the craft and it had no color and was not a shadow but a glow. The object seemed to have light of its own, not a reflection. It was about twice as large as a full moon. It had points on the side which seemed to be projections rather than part of a rim. The object remained perfectly still. It was a very quiet night with no sound from wind or animals.

When [redacted] called [redacted]'s attention to it, she stopped the car and they watched it. The car was not affected. It was in their view about a minute and a half when they became frightened and drove away.

They never reported this sighting except to friends and family. Her brother, now 12 years old, is [redacted] Brighton, Colorado. I had hoped to have an opportunity to talk to Joe also but was not able to.

[redacted] said the object was beautiful. It did not move away from the area or disappear, but rather, Joe and [redacted] left.

[redacted] went to Brighton Junior High, St. Mary of Euphrasia High School from which she graduated, worked in Denver Colorado before marriage. Her brother goes to school in Brighton.
