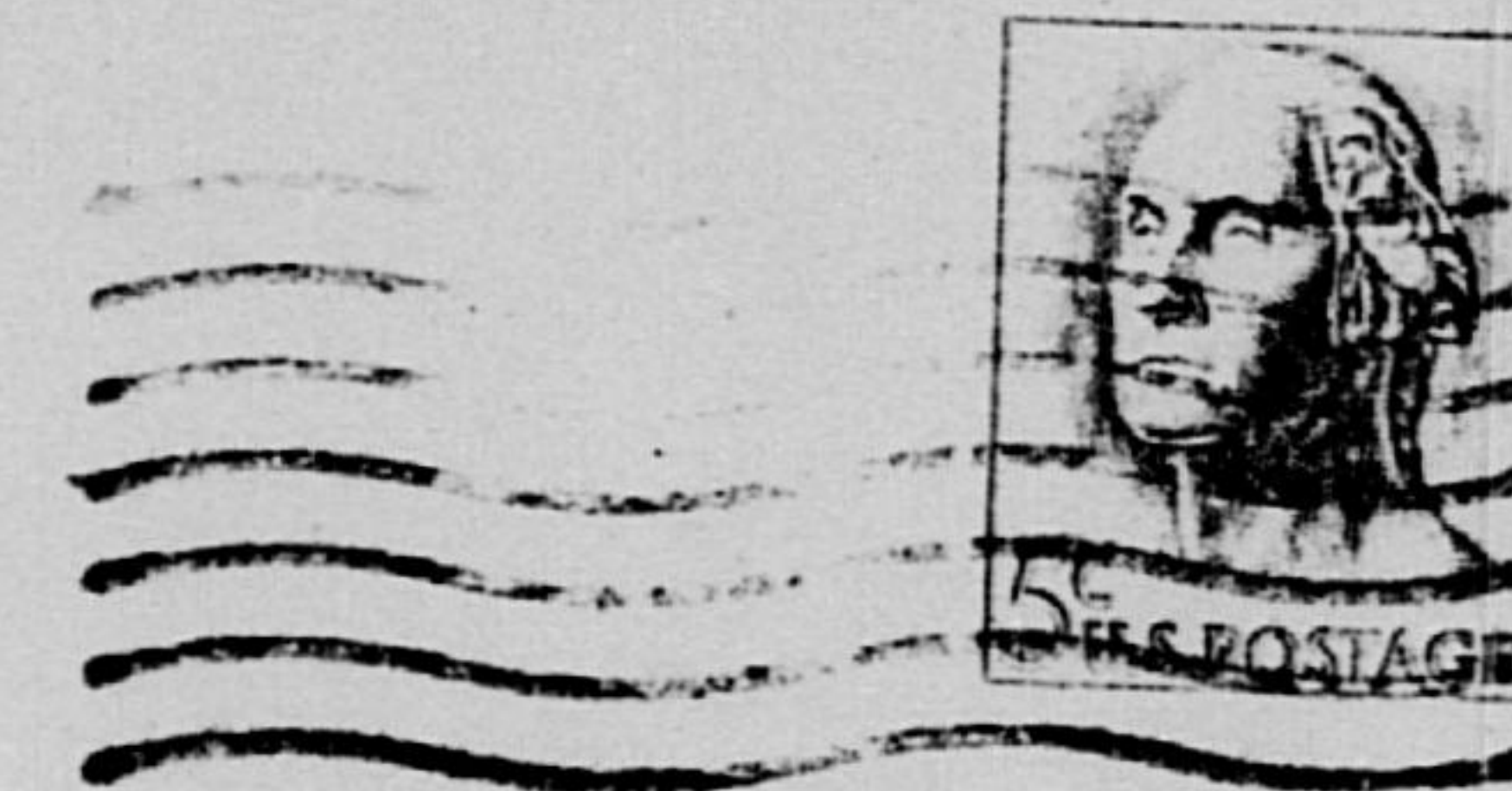

Dear Sirs;

I am writing to ask you if you would happen to know if any of our satellites or any of the satellites belonging to the U. S. S. R. have ever been launched into orbit parallel with the prime meridian. I thought most satellites were launched parallel with the equator and have not thought much about it until recently. This is why.

On Saturday, September 4, at 7:20 P. M. Eastern Standard Time, I happened to notice an unusually brilliant light in the sky directly east. At first I thought it was an illusion until I compared it to the stars around it and found that it was moving. I rushed inside, told my parents and two brothers about it and we all went back outside and watched it. My mother judged it to be at least 100 miles away and above the clouds. We clocked it and found it took ten minutes for it to travel from a position directly east of us to a position north east of us where we lost track of it. During the course of its flight, it once

The objects which you sighted on the nights of 4 Sep and
6 Sep correspond with the passage of the satellite Echo II.
Echo II was to the east of Tampa at 7:25 p.m. on 4 Sep at
25 degrees elevation heading northeast. On 6 Sep the satellite
was to the north of Tampa at 8:07 p.m. at 77 degrees elevation
moving northeast and at 9:54 p.m. passing to the west of the
city heading northeast. The apparent hesitation in flight is
a common illusion as one light, in this case Echo II, nears
another light such as a star. In addition to the satellite Echo II,
there are more than 30 satellites and space debris visible to
the naked eye.



Dear Sir:

About two years ago I bought a book by Donald Keyhoe. It was entitled Flying Saucers: Top Secret. I have never been a skeptic when discussion of flying saucers was going on and as time went on I have read many other persons views on these UFO's. As a result of these readings I have become more interested than ever in learning all I can about them. However, I realize that so much material is classified and cannot be made public.

About a month ago I was sitting outside when I happened to notice a very brilliant object in the sky. Naturally, at first, I just thought it was a very bright star, but as I watched it very closely, I could see that it was not a star. This object whatever it might have been was stationery for about fifteen minutes as I watched it and then it moved very rapidly going Northeast and growing so faint (as if were ascending) that after just a very few seconds it was out of sight. I was not the only one who saw it.

This was not the first of such glowing objects as I have seen nor was it the last. On several occasions and always with witnesses that at least there was this glowing, rapid moving object, I have seen this object which appears to twinkle but is of such brightness and appears to low to be a star. On September 3rd, Friday at 10:45 I saw another of these and it has prompted this letter. It was of a brilliant color, similar to a silver or an aluminum which is reflecting light. It appeared to be just north of us around the area of Dayton. There were it seemed lights of a reddish nature and also green or blue lights. It was twinkling in such a way that it reminded me of a Christmas tree ornament which glows from the oscillating. Or at least that wa my impression.

We are in receipt of a letter from [REDACTED] reporting sightings of unusual objects. Her observation on 3 Sept 65 at 1045 pm is similar to many reports which our project has received on meteors. Her previous observation is more difficult to explain and data presented was not sufficient for evaluation. It is suggested that an FTD Form 164 be sent to her along with a Fact Sheet and explanation that Mr Keyhoe's books are regarded as science fiction by the Air Force.

Your observation on 3 September 1965 is similar to many reports of observations of meteors.

The data which you presented on your first observation is insufficient for evaluation. I am enclosing a copy of FTD Form 164 which is used for making such reports to the Air Force. This form should be completed as fully as possible and returned to this office so that an evaluation can be made.

I am enclosing a report on Project Blue Book, the Air Force UFO project. This report contains information on this program since its origin in 1947. I hope this will be of interest to you.

The books by Donald Keyhoe are considered by the Air Force to be science fiction.
