The following information would aid in the photo analysis:

- a. Type and make of camera,
- b. Type, focal length, and make of lens,
- c. Brand and type of film,
- d. Shutter speed used,
- e. Lens opening used; that is, "f" stop,
- f. Filters used,
- g. Was tripod or solid stand used,
- h. Was "panning" used,
- i. Exact direction camera was pointing with relation to true north, and its angle with respect to the ground.
