PART I. DESCRIPTION OF COURSE: APPEARANCE OF LIGHTS FIRST CAUGHT ATTENTION OF OB SERVERS. OBJECTS APPEARED TO BE VERY HIGH; VERY FAST. OBJECTS REMAINED IN SIGHT FOR PROLONGED PERIODS OF TIME. FLIGHT PATH

PART III. OBJECTS WERE SIGHTED VISUALLY FROM THE GROUND. NO OPTICAL AIDS WERE USED.

PART IV. SIGHTINGS OCCURED BETWEEN 1130PM 24 MARCH TO 0200 25 MARCH.

PART V. OB SERVERS WERE LOCATED AT WAUSAU, MARSHFIELD, ATHENS, AND STEVENS POINT, WISCONSIN.

PART VI. SOME SPECIFIC OB SERVERS WERE: STANLEY OLEJNICKYAK, 27; DEXTER WOODWARD, 30; RICHARD MUELLER, 38; RICHARD EISNIE, 24;. ALL ARE MEMBERS OF THE MARATHON COUNTY SHERIFFS DEPARTMENT AND RELIABLE SOURCES OF INFORMATION. MANY OTHER CITIZENS REPORTED SEEING THE OBJECTS. NO MILITARY PERSONNEL WERE INVOLVED.

PART VII. WEATHER CONDITIONS: WEATHER WAS CLEAR, WITH STARS READILY VISIBLE. SURFACE WINDS APPROXIMATED 15 KNOTS. CEILING WAS UNLIMITED. VISIBILITY WAS 20 MILES, THERE WAS NO CLOUD COVER. THERE WERE NO THUNDERSTORMS IN THE AREA. WEATHER STATIONS IN THE AREA REPORTED NO UNUSUAL WEATHER PHENOMENA.
