I first thought was an unusual

eyes flashed wide open. I looked
out of the window and took a
good look at it. I looked at the
clock and it was just 5:20.
Then looked around at the sky
for other stars, but there ^{Send 164} were none -
it was just dawn,

Then when I looked at it again it was next to another tree nearby, so I knew it was moving but it did not appear to be.

Next, it ~~was~~ landed on the ground about 8 feet east of where I was standing in the window of my home.

It was a large round silvery looking light with long lighted points all around it. I could not see anyone who might be operating it.

A friend of mine who also lives in Beverly Shores was over last evening and she has been ill ever since one evening recently when she went out to her coal shed to get some coal, and on her way back to the house she sighted in the sky overhead what she thought was a "Flying Saucer" with a red caplike cover over it. Immediately she touched a wire which was hanging in the air from the "Flying Saucer" above her, and it gave her an electric shock.

Now, these things are not good, and I hope you will make an investigation on them.

UFO Sighted By Deputy Called Star

WASHINGTON (AP) — That object in the sky Deputy Sheriff Dale F. Spaur of Ravenna, Ohio, said he and his partner chased for an hour and a half last Sunday probably was the planet Venus, says the Air Force.

Spaur reported "somebody had control over" the object. But the Air Force said "radar indicates that no airborne objects were in the area at the time of the sighting." Venus was rising in the southeast at the time, the Air Force said, and was brighter than any star in the sky.

The same night, Police Chief Gerald Buchert of nearby Mantua, Ohio, said he took a picture of an object resembling "two table saucers put together." Concerning Buchert's claim the Air Force said:

"Photoanalysis of the negative . . . indicates that the 'very bright light' which he tried to photograph does not appear as an image. The two images which appear on the negative are probably the result of processing defects due to old fogged film and poor handling . . ."

Hundreds of persons in both Ohio and Pennsylvania reported seeing a "brilliant and shiny" object in the sky early Sunday. The Air Force did not comment on this.

Dear Sirs -

Recently, amongst other letters, I wrote to you
on April 7, 1966, and made other contacts in
accordance with advice from authorities here.

My letter to you advised you in regard to
my experience on March 30, 1966, with a UFO
which I first sighted amongst the tall
treetops about 50 feet from my home, and
within a very short time it landed on the ground
about 8 feet from the window where I was
standing watching it, and from the large center
light it then had long lighted points all
around it. I looked at the clock, and it
was then just 5:20 AM. It stayed on that spot
until 6:30 AM.

I have not received a reply from you
acknowledging receipt of my letter to you,
astro (Venus) & moon

and I am wondering if you received it.

I heard yesterday that these U-70s have been seen near homes here and the operator has touched the electric wires with something, evidently tapping them for electric current at the expense of the property owners.

Now, in regard to the enclosed clipping from my yesterday's Gary Sunday Post-Tribune, wish to advise that at 4:30 AM (just dawn) Sunday morning (April 17, '66) I also sighted a large round white light in the east coming up over the horizon. At first I thought it was the sunrise, but on second thought I realized that the sunrise would be red - not white - so I watched it flying closer - and slowly - until it was over the flat properties nearby.

Then suddenly a bright red light shone on the right side of my face which had come in through the 3 window panes in my front outside door. It was scooting very fast ^{eastward} along the ridge of the dune across the street from my home,

Then crossed Broadway, which is about 300 feet east of my property, then up in the sky until it met the white lighted object which had come from the east, but below it, for just a couple of minutes - then flew fast again northward into the duneland. The white light then disappeared. It was very evident that they had made an appointment to meet in this area for the purpose of conveying a message, which accounted for the red light flying beneath the white one so the written message could be dropped to him on a wire or string.

This may have been what was chased by Deputy Sheriff Dale F. Spaur and his partner, of Ravenna, Ohio, the same morning. It very definitely was not Venus.

I have reasons to believe that Russians are operating these UFOs, and my next contacts will be with President Johnson and our U.S. Senator Birch E. Bayh.

These mysterious things are something that should not be disregarded, especially in times of War, and I am determined to continue my contacts until there is some development in the solution of this mystery.

I should appreciate some word from you which will throw some light on the subject.
