1. The following information is presented as directed by AFR 200-2, paragraph 14.

a. Description of object:

- (1) Shape: Slightly pear-shaped.
- (2) Size: Baseball.
- (3) Color: Bright white light.
- (4) Number: One.
- (5) Formation: None.
- (6) Discernible Features: None.
- (7) Tail, trail, or exhaust: None.
- (8) Sound: None.
- (9) Other features: None.

b. Description of course:

- (1) A bright, glowing white light observed in the sky.
- (2) Approximately 45° to the left of the observer, at an elevation of 35° to 45° (observer was facing NE).
- (3) Approximately 45° to the right of the observer, at an elevation of 40° to 60°.

(4) When first sighted, the object appeared to be bouncing or oscillating until it was directly in front of the observer, where it seemed to stop and hover. A small, brilliant light appeared to leave the bottom of the larger object and descend into the water, where it was no longer visible. The larger object then appeared to descend and hover over the spot where the smaller object had entered the water. It then climbed straight up to approximately the position of the first hover and hovered once more.

(5) Upon completion of the second hover, the object started climbing at approximately a 60° angle. Acceleration seemed slow at first, but rapidly increased until the object disappeared from view.

(6) Object was visible for 5 to 6 minutes.

c. Manner of Observation:

- (1) Ground-visual.
- (2) No optical aids were used.
- (3) N/A.

d. Time and Date of Sighting:

(1) 0800 to 0830 Zulu, 18 April 1966.

(2) Night.

e. Location of Observer:

(1) 36 57 1/2 N, 76 15 1/2 W (observer was facing NE).

j. A thorough check of Naval, Air Force, NASA and FAA installations in the area failed to indicate any aircraft or balloon which would account for the sighting.

k. This report was prepared by Captain James R. Lewis, Jr., USAF, 4500 Air Base Wing Operations Division, Langley Air Force Base, Virginia. After exhausting every possible avenue of investigation open to me, I am unable to substantiate nor disprove the validity of this sighting.
