- (4) It rose rapidly, went straight up toward the northeast, then turned and went south, still climbing.
- (5) Slowly to the south until lost from view.
- (6) About three minutes.

Although this object was seen on the night of 4 July near an airport, the observer said he was positive it was neither a fireworks display nor an aircraft.
