PARA 14J: TWO B-52 AIRCRAFT FROM THE 97TH BOMBARDMENT WING, BLYTHEVILLE AFB, ARKANSAS, WERE AIRBORNE IN THE LOCAL AREA APPROXIMATELY AT THE TIME OF SIGHTING. THESE AIRCRAFT WERE SCHEDULED TO LAND 250045Z AND 250056Z OCT 1966, RESPECTIVELY. OBSERVER WAS ADAMANT IN STATING THAT THE OBJECT SIGHTED WAS NOT REPEAT NOT AN AIRCRAFT. OBSERVER'S DESCRIPTION OF THE FLIGHT PATH, SPEED, AND ALTITUDE OF THE OBJECT INDICATES THAT IT PASSED THROUGH AN ARC OF APPROXIMATELY 100 DEGREES IN APPROXIMATELY ONE MINUTE AT AN ALTITUDE THAT WAS "VERY HIGH." THESE CONDITIONS SUGGEST THAT THE SPEED OF THE OBJECT WAS CONSIDERABLY IN EXCESS OF THE OBSERVER'S ESTIMATE OF 1,000 MILES PER HOUR, AND IN
