




I am writing this letter because my father and I witnessed a U.F.O. On Dec 4, 1966 when coming home from a football game I noticed a bright red blinking light in the sky. As we turned on a side road I told my father to stop the car. When he stopped we watched this object just sit over our heads, probably a couple of hundred feet high only for a couple of minutes. As we got into to car the object started slowly to descend. Then after a while it vanished.

It was a very cold and clear night. When I saw it the object ^{it} was coming from the north. It wasn't an airplane because this object didn't make any sound. It kept
