MATELY FOUR HOURS. THE FIRST WAVE OF 16 AIRCRAFT, 8 OF EACH TYPE, WAS INITIATED AT 030200Z AND THE FIRST TAKE-OFF WAS APPROXIMATELY 0215Z FOLLOWED BY THE REMAINING 15 AIRCRAFT AT APPROXIMATELY 1

MINUTE INTERVALS. THE SECOND WAVE WAS INITIATED AT 030400Z AND THE FIRST TAKE OFF WAS AT APPROXIMATELY 030415Z FOLLOWED BY THE REMAINING AIRCRAFT AT APPROXIMATELY 5 MINUTE INTERVALS. THE FLIGHT PATH OF ALL AIRCRAFT DURING A BAR NONE EXERCISE IS SUCH AS TO PLACE THEM IN SIGHTING AREA DURING AND AFTER THE TIME OF SIGHTING. PARA 14K (K ILO): CHIEF, INTELLIGENCE DIVISION, 97TH BOMBARDMENT WING, BLYTHEVILLE AFB ARKANSAS. COMMENTS: THIS SIGHTING IS SIMILAR TO THAT REPORTED FROM KENNEDY, MISSOURI ON APPROXIMATELY 24 AUGUST 1966 WHEN THE 97TH BOMBARDMENT WING EXECUTED AN OPERATIONAL READINESS INSPECTION TEST (ORIT). UNCONFIRMED INFORMATION INDICATES SIMILAR OBJECTS, AS MANY AS 7 AT ONE, HAVE BEEN OBSERVED IN THE SAME AREA FOR THE LAST SEVERAL NIGHTS. FLIGHT RECORDS OF THE 340TH BOMB WING AND THE 97TH AIR REFUELING SQUADRON AT BLYTHEVILLE AFB, BOTH OF WHICH WERE INVOLVED IN THE BAR NONE EXERCISE, INDICATE THAT BOTH UNITS CONDUCTED EXTENSIVE NIGHT TRAINING ON 11 FEBRUARY AND 1 MARCH 1967. IT IS NOT UNUSUAL FOR BOTH BOMBERS AND TANKERS TO FLY IN THE
