

Then got my binoculars out to get closer look.



The light I saw at first appeared to be a bright star - or a satellite reflecting sunlight. (However, it was about 8:30 PM, so too late to catch last rays of sun). Upon getting my binoculars and my truck & observing the object, I could see about 4 sources of light in a group. Each looked like the open end of an old fashioned kerosene stove - a ring of fire. I thought the possibility of my observing the exhaust from some plane, but could think of none with the arrangement of power plants. Besides, it was coming to me, not going away The group of lights traveled in a south-easterly direction from where first observed.

Ref. 13-c. After I had been watching the four sources of light a while, one seemed to go out. I took a look at it without my binoculars then, and the light seemed dimmer, and I thought I saw a streak of fire or something burning drop under it. Watching again with binocs, I saw a streak of flame or burning object fall from the group of lighted fires and drop down earthward in an erratic path:

13-c-2 Total light left was diminished again. I lowered my glasses again to check with eyes only and the brightness diminished again as a burning or glowing object fell away from it. Again using binocs I found the light again, and it seemed to be down to just one dim light source or ring, and this suddenly went out as I watched. Then as I continued to ~~to~~ watch that area I seemed to distinguish a silvery or silken looking parachute or balloon reflecting light from the city below. By this time the object had drifted to the east of Tempe several miles and was about as high above the horizon on that side of me as it had been on the N.W. when first observed.

Discussing the matter with Capt. Redding of USAF leads me to believe that this was probably a hot air balloon experiment, powered by several candles on a suspended platform inside it. The "ring" fire effect I noted would be the light diffusion around each candle when seen through clear or milky plastic. (over)

Friends to whom I related my tale the next day spoke of seeing an article in the morning paper recently regarding students in L. A. area making these hot air balloon experiments and this may well have induced some local people to try the same thing.

I might add that Capt. Redding's investigation of this matter has been a credit to the Air Force. He was courteous but thorough in questions, and afterward related to me what further he had found out (not much!) about the matter.
