1. Shape: Red flashing light in sky - motionless. Estimate 20 miles away.
2. Size compared to a know object: At that distance it looked like the red flashing light on top of a police car when it is approximately 100 yards away.


UFO Report (Your Ltr, 5 Jun 67)

1. Your UFO Report, on a unidentified flying object observation of 4 May 1967, is being returned to your office so that your UFO investigating officer will have the opportunity of evaluating the information contained in his report.
2. The information in this report is not only confusing but worthless as a tool in evaluating a UFO sighting. Specific and detailed information is needed when filling out a UFO report. It is quite apparent that someone went through the motions of filling out the report without giving much thought to its content.
3. We do not intend to "nit pick" the report, however, as an example of incomplete information we would like to bring to your attention the information contained in paragraphs B1,2,3,4, and 5. We cannot determine in which direction Mrs. Kemp's window faces; therefore, we cannot determine in which direction the observer was looking when she spotted the UFO. The report states that the elevation of the object was 5° above the trees. How tall are the trees?
4. Request you reaccomplish this report in accordance with all the provisions of Air Force Regulation 80-17.




