MEMO FOR THE RECORD

18 Sept. 1967

Called Coast Gaurd (231-1570) and talked to Lt. Potter. We had thought that the observation may have been of one of the search boats that were looking for bodies of parachutists that landed in the lake on 27 Aug. Lt. Potter said records show that there was no search under the direction of the Coast Gaurd on the night of Aug. 29 or early morning of Aug. 30. (Coast Gaurd search was terminated at sunset 29 Aug. till dawn of the 30th.) However there were many private boats in the area at that time and the Lt. thought that some of them should have been visible.
