<p>The observer sighted a conical object that appeared to have red and green lights revolving around it in a circular pattern. The observer said that it hovered at the end of a field about 150 yards from his car for about 15 minutes then it sped away.</p> <p>COMMENTS: The observer said that he returned to the area/again that evening and saw three similar objects. The observer also stated that "since seeing this event we look for them while deer spotting and have since seen them with different persons riding along. One of the observer's witnesses said that he had seen similar UFOs numerous times in the vicinity of Cowansville. It is felt that the observers are not very familiar with aircraft and that this could be what they saw and have since seen so many times. However, because of the numerous occasions that they have seen UFOs the sighting is being carried as UNIDENTIFIED."</p>




On the 13th of September, 1967 while on a deer spotting trip I and two others saw an object with red and green lights revolving around in a circular pattern at the end of this field. I placed the spotlight on the object as it moved down the ^{of rough color} field's center and it appeared to be concave in shape and made no noise. It hovered at the end of the field about 150 yds. from our car and observed us for about 15 minutes. It then sped away with the lights changing to a reddish blue.

Returning back to this area this evening we deserved 3 similar objects in the sky moving across at high speed without engine sound. The lights on these craft rendered also but did not have the red-green color to them. The sightings were made in the vicinity of the Mahoning Flan area in Armstrong County near the town of Kittanning (about 25 miles from Kittanning). It seems the object of the 13th was about 80-100 ft in length.

I am a teacher of biological science at the local high school. Other sightings have been made by a Mr. Blose who owns a farm in Rural Valley. He is math teacher at the school.

I did not believe that such things existed but now I am not sure. If you people are interested I would be glad to show you the area. You could speak to Blose if you wished. We do not want anything reported to the press because people these days just don't think this is possible and being in this profession you watch what you say. In case of this native people and the press have said that the people involved played a hoax. We will supply all the information about these cases if it is kept quiet.






