A report of an unusual flying object was received at this base by SSgt J.A. Booth the 5th of Dec 1968 at 2205. The reporter, [REDACTED] called by telephone and his description of the incident can be found in Appendix I of this report.

On receiving the report SSgt Booth reported the incident to Lt. Donald E. Waddell, UFO Officer for the 664th. The 6th of Dec Lt. Waddell contacted Wright-Patterson AFB (TDETR) reported the incident to Sgt Jones who instructed a follow up report be filed as per AFR 80-17.

The same day Indianapolis ARTCC was contacted concerning the incident. The watch supervisor said no unusual air traffic was observed in the area the 5th but that it was impossible to determine how much air traffic was in the area at the time. The Ohio State Patrol said no other reports were received concerning the sighting.

A personal interview with the witness raised some speculation concerning the credibility of this story as he contradicted himself several times. The object, he said, was observed between 2005-2020, approximately 30° above the horizon, moving first east then to the south. The object was observed while the individual was driving (a 1960 Cheverolet) on state road #9 at 50-55 mph. He further described the object as light in color, self-illuminating, solid circle with fuzzy edges. It was about the size of a grapefruit and two miles away. Asked if it was his first sighting of such an object, [REDACTED] said yes but later told of a similiar experience in April of 1968 in the same general area which he described as follows: a black object heading towards him at a moderate rate of speed which when in coming to him turned 90° and at the same time turned a bluish-white and disappeared. There was another observer to this particular avent but [REDACTED] did not know who it was.

Originally he indicated that the sky was clear of any objects such as air traffic during the sighting but later said that it was a small aircraft flying north in the area which first drew his attention to the object.

The witness is a male, 19 years of age who is an assembly line worker at Airstream Manufacturing Co. His address is [REDACTED] Bellefontaine, Ohio. No scientific or technical background and is a high school graduate.



## APPENDIX I

I was heading east, object was heading east on county road 25, object was ahead a little bit to the left front of car, could look through windshield, front, withease, I turned south on county road 9, object still went straight on ahead. When I passed a house, which was on left side of road, I noticed object was now going southerly direction, and I could see it with ease through left front door window. When I turned onto state road 47 object also turned in direction I did toward Bellefontaine. Object appeared not to make any precise 90 turns. When I got to Williams & Main St. the object took off quickly, straight up when I stopped. Coming to Bellefontaine I could see the object with ease through left front door window. I had stopped three times and object stopped at same time. Third time I stopped there weren't any buildings close by and slight wind. I rolled down window, thinking it might have been a reflection on window, but object still appeared in sky. Object made high pitch humming sound. Object looked round and bluish-white in color. I couldn't tell size, appeared to be about 2 miles from car. At this time I was about one mile from state road 47. Sky was clear, I didn't see any clouds.
