This replies to your letter postmarked December 14, 1968, in which you inclosed some photographic prints.

In order for us to evaluate a photograph, we must have the original negative (or original Polaroid print). If you care to send us the original negatives, we will have them analyzed. The following information will also be needed:

- Type and make of camera
- Type, focal length, and make of lens
- Brand and type of film.
- Shutter speed used
- Lens opening used; that is, "f" stop
- Filter used, if any
- Was tripod or solid stand used
- Was "panning" used
- Exact direction camera was pointed with relation to true North, and its angle with respect to the ground

If all of the above information is not available, minimum requirements are type of camera, and smallest and largest "f" stops and shutter speed readings of the camera.

The prints you sent us are inclosed.


1. 




