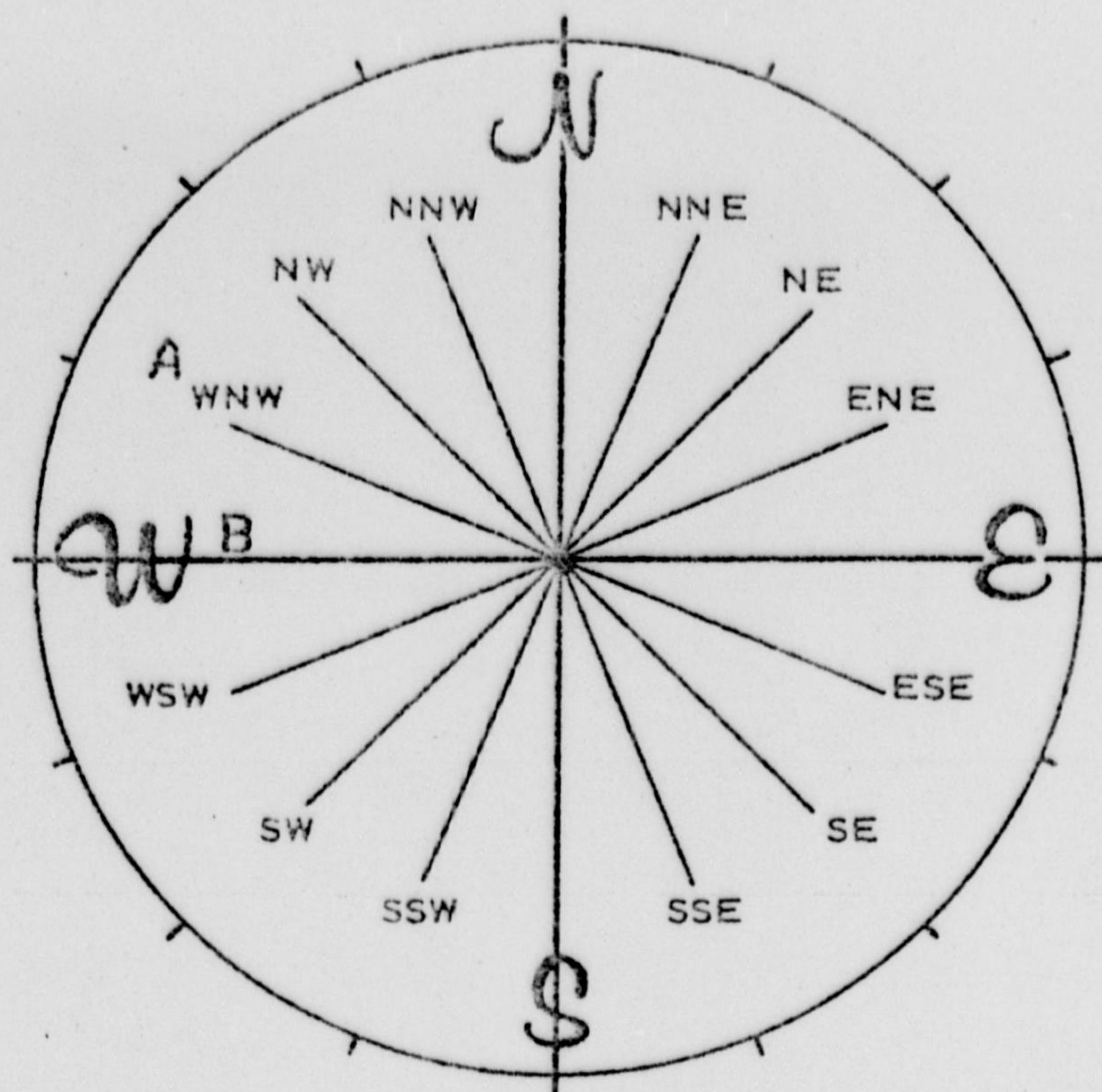

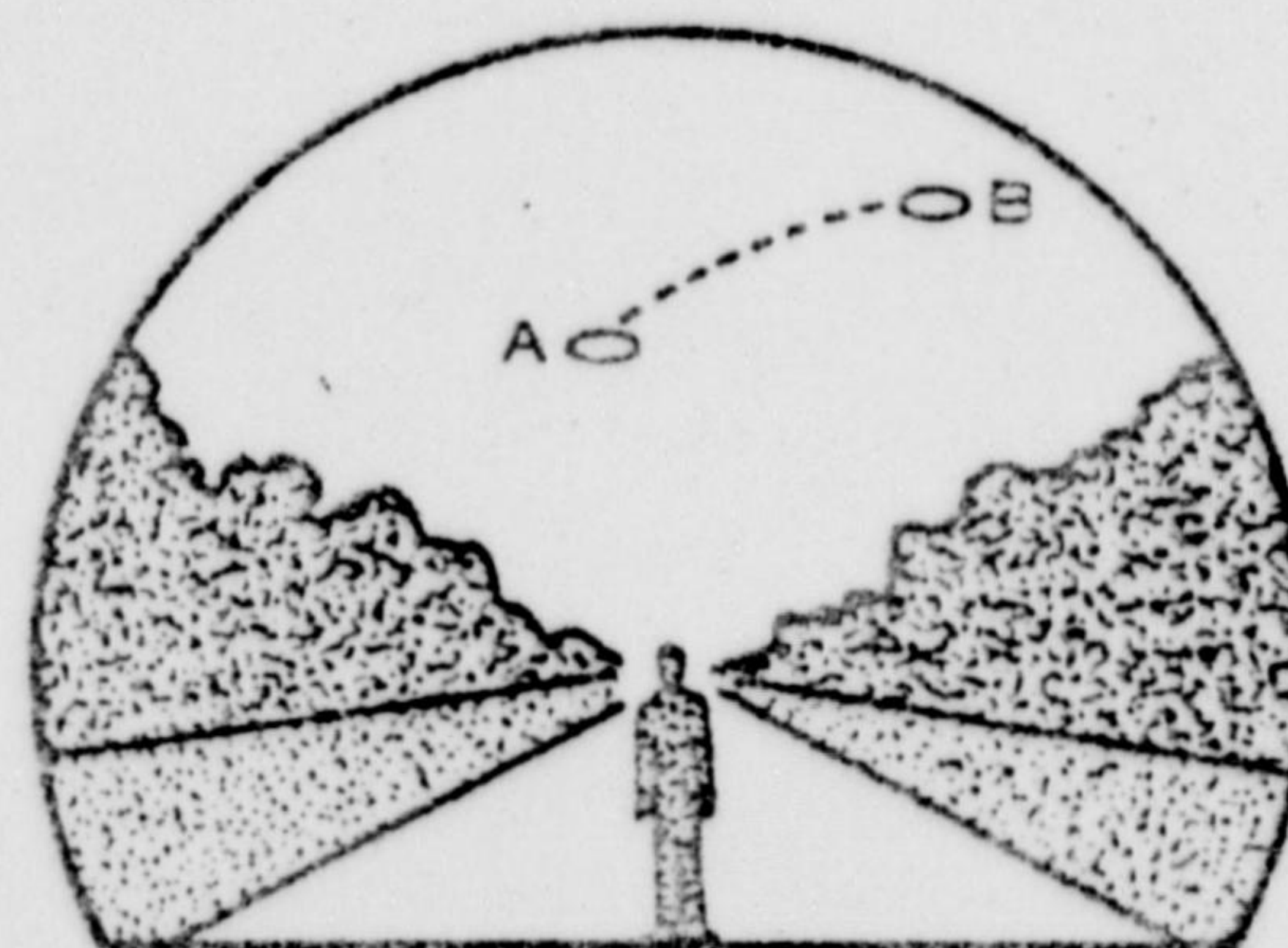
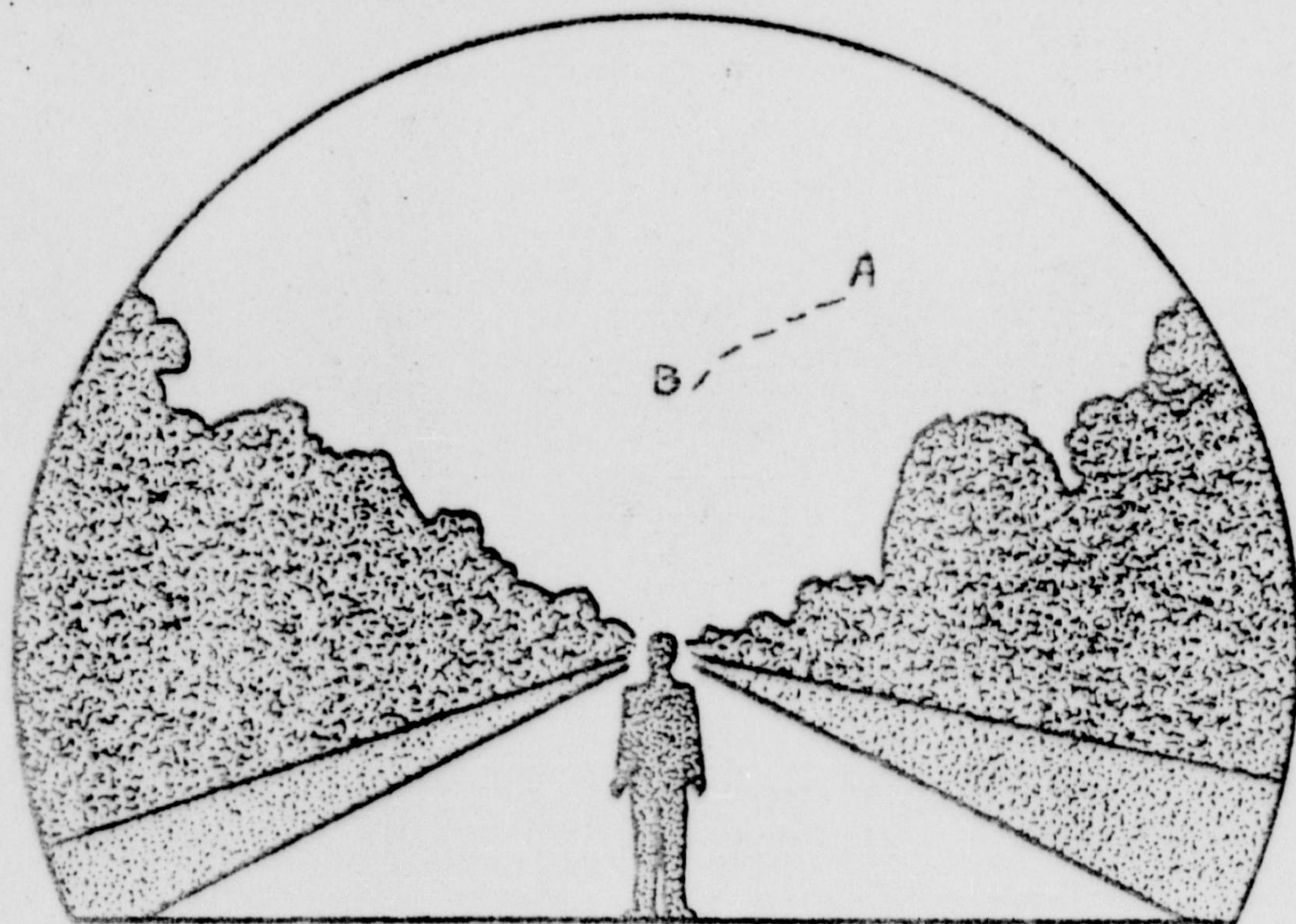

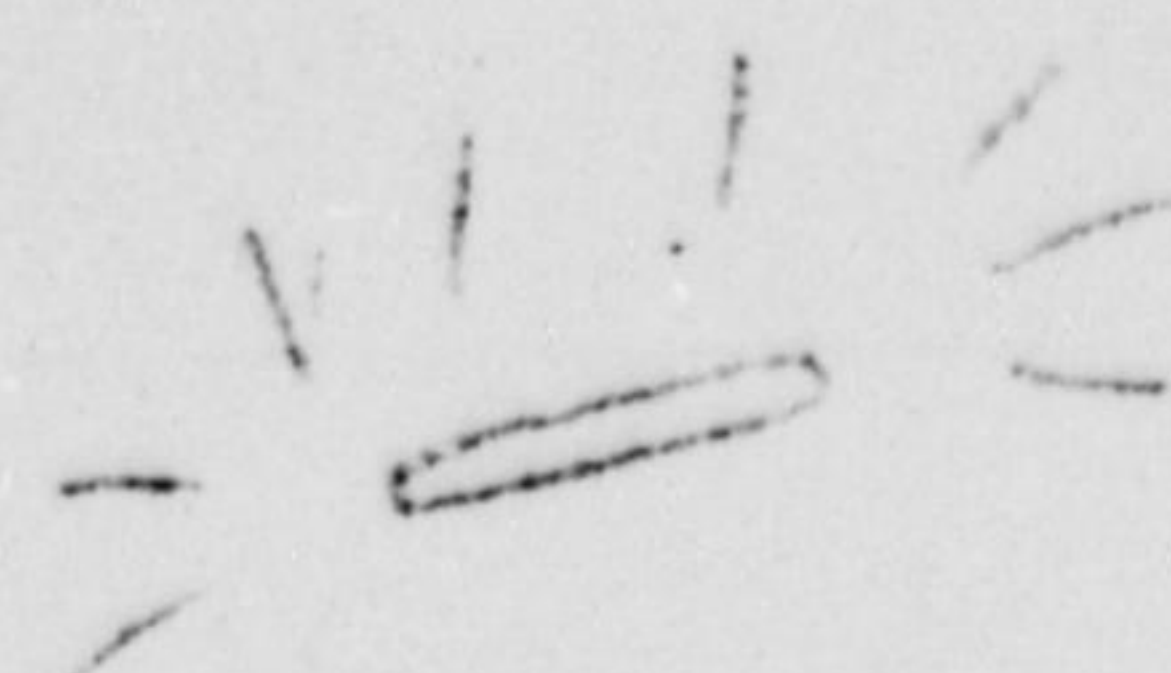

AS I MENTIONED BEFORE, IT WAS ALMOST OUT OF SIGHT BEHIND THE BUILDING WHEN IT DISAPPEARED. I INSTANTLY LOOKED AT [REDACTED] AND ASKED HIM IF HE SAW IT AND HE SAID, "YES, BUT I DIDN'T WANT TO SAY ANYTHING BECAUSE YOU WOULD THINK I AM CRAZY." WE JOKED ABOUT IT FOR A FEW MINUTES AND STARTED WATCHING THE SKY HOPEFULLY WANTING TO SEE A "FLYING SAUCER". WHEN WE STARTED SEEING IT AGAIN AT ALMOST THE EXACT SAME POSITION AND DIRECTION FOR THE THIRD TIME IN A ROW, WE REALIZED THE SITUATION WAS FAR MORE SERIOUS THAN WE THOUGHT. INCIDENTLY, AFTER THE FIRST TIME I SAW IT, IT NO LONGER HAD THE ROUNDISH SHAPE BUT A MORE STUB LIKE SHAPE. I WENT INTO THE HOUSE AND GOT INFORMATION FROM THE TELEPHONE OPERATOR WHERE THE REPORT COULD BE MADE. WHILE I WAS TELEPHONING A.C.I.C., [REDACTED] AND HIS WIFE WENT BACK OUTSIDE AND SIGHTED IT TWO MORE TIMES.
